LINCOLN COUNTY, MONTANA RESOLUTION ADOPTING LINCOLN COUNTY MULTI-HAZARD MITIGATION PLAN 2019 UPDATE

THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY,
MONTANA FINDS:

1. In October of 2000 the President of the United States signed into law the "Disaster Mitigation Act of 2000" (PL 106-390) to amend the "Robert T. Stafford Disaster Relief and Emergency Act of 1988" which among other provisions requires local governments to adopt a Multi-Hazard Mitigation Plan in order to be eligible for hazard mitigation funding;
2. Lincoln County, Montana has worked closely with Lincoln County Emergency Management Agency to update a county-wide Multi-Hazard Mitigation Plan that will serve the needs of Lincoln County;
3. Lincoln County supports the 2019 Update to the Lincoln County Multi-Hazard Mitigation Plan as a logical means toward protecting people and property from the potential devastating effects of natural and man-made hazards;

THE BOARD RESOLVES:

That the Lincoln County Board of County Commissioners adopt, by way of this resolution, the "Lincoln County, Montana Multi-Hazard Mitigation Plan – 2019 Update" as approved by the Montana Disaster and Emergency Services and the Federal Emergency Management Agency.

THE BOARD FURTHER RESOLVES:

1. If a provision of this resolution conflicts with a provision of a previously adopted resolution, this resolution will prevail.
2. This resolution and its various sections, clauses and paragraphs are severable. If any part, sentence, clause or phrase is adjudged to be unconstitutional or invalid, the remainder of the resolution will not be affected.
3. This resolution will be effective immediately upon adoption, in accordance with § 7-5-123,
