 - The board discussed options for composition of the governing body. Josh has talked to Eureka, Troy and Libby. Would also like to include Rexford. Jinnifer Mariman, attorney, explained that either bylaws or interlocal agreements could be amended.

New Business

- Alcohol Use in Montana, Nicole Mitchell
 - Nicole works for Western Montana Mental Health Center and is the program manager for the northwest region of prevention services. Nicole presented statistics on the use of alcohol among Lincoln County youth. She showed the data on the Youth Risk Behavior Survey (YRBS), which is given to 9th-12th grades every 2 years as well as the Montana Prevention Needs Assessment given to 8th, 10th and 12th grade youth every other year.
- Nutrition Resources/Programs, Annette Galioto
 - Annette works for the MSU extension and nutrition education program through SNAP. This program mainly focuses on lower income families. She teaches kids throughout the school year as well as parents and senior citizens. Her classes include learning how to make better food choices, sanitation, and also cooking. Annette stressed the importance of poor food choices and the effects it has on the body. Individuals that participate in her classes are usually on SNAP and can get an extra \$10 from SNAP to spend at the farmers market in Libby. Linda Alkire called in and commented on the high carbohydrate and high sugar foods that are being donated to the food pantry and encourages people to be more mindful of what they are donating.
- Action Item: Variance request, Lanti Carlson
 - Lanti Carlson requested a variance request for his septic drain field. He installed it 7 feet from the property line but the requirements say it needs to be 10 feet away. Jesse Haag explained to the board that there wasn't much

room for the drain field to be moved because of the shape and size of the property. He expressed there was no danger to other wells or structures. Jan motioned to approve. Amy seconded. All in favor. Motion passes.

 - Kathi Hooper said commissioners approved purchasing the program for Environmental Health.
