Resolution Authorizing Submission CDBG Application

**THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY,
MONTANA FINDS:**

1. Lincoln County is applying to the Montana Department of Commerce for financial assistance from the Community Block Grant Program (CDBG) to replace septic systems, including drain fields for Libby Creek Community.
2. Lincoln County has the legal jurisdiction and authority to construct and finance the septic systems and drain fields.

THE BOARD RESOLVES:

1. That Lincoln County agrees to comply with all applicable parts of the Title I of the Housing and Community Development Act of 1974, as amended, which have not been cited herein, as well as with other applicable federal laws and regulations, and all State laws and regulations and the requirements described in the CDBG Application Guidelines and those that will be described in the CDBG Project Administration Manual.
2. That Lincoln County commits to provide the amount of matching funds as proposed in the CDBG application.
3. That Mark Peck, Chair of the Lincoln County Board of Commissioners is authorized to submit this application to the Montana Department of Commerce, on behalf of the County of Lincoln, to act on its behalf and to provide such additional information as may be required.

THE BOARD FURTHER RESOLVES:

1. If a provision of this resolution conflicts with a provision of a previously adopted resolution, this resolution will prevail.
2. This resolution and its various sections, clauses and paragraphs are severable. If any part, sentence, clause or phrase is adjudged to be unconstitutional or invalid, the remainder of the resolution will not be affected.
