## Resolution 2019-17

### A RESOLUTION APPOINTING SPECIAL DEPUTY COUNTY ATTORNEY FOR THE PURPOSE OF ASSISTING WITH PROSECUTING VIOLATIONS OF TITLE 45 OF THE MONTANA CODE ANNOTATED

**THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY,  
MONTANA FINDS:**

1. The Lincoln County Attorney is responsible for prosecution of criminal cases pursuant to § 7-4-2712, Montana Code Annotated;
2. Montana Code Annotated §7-4-2707 authorizes the appointment of another attorney to perform criminal services for Lincoln County; and
3. The Lincoln County Attorney has requested that the Board of County Commissioners appoint Jinnifer Jeresek Mariman, of McGarvey, Heberling, Sullivan & Lacey, P.C. to occasionally assist in prosecuting criminal offenses on a pro bono basis.

**IT IS HEREBY RESOLVED:**

That Jinnifer Jeresek Mariman is hereby appointed as special deputy county attorney for Lincoln County for the purpose of occasionally assisting with the prosecution of criminal cases.

**IT IS FURTHER RESOLVED:**

That the special deputy county attorney shall serve without payment of costs or fee by Lincoln County.

**THE BOARD FURTHER RESOLVES:**

1. If a provision of this resolution conflicts with a provision of a previously adopted resolution, this resolution will prevail.
2. This resolution and its various sections, clauses and paragraphs are severable. If any part, sentence, clause or phrase is adjudged to be unconstitutional or invalid, the remainder of the resolution will not be affected.
