A RESOLUTION OF INTENT OF THE BOARD OF COUNTY COMMISSIONERS OF LINCOLN COUNTY. **MONTANA** TO ADOPT THE LINCOLN COUNTY GROWTH POLICY 2019 UPDATE.

FINDS:

- THE BOARD OF COMMISSIONERS FOR LINCOLN COUNTY, MONTANAS:

 In 2009 the Board of Commissioners for Lincoln County, Montana adopted the Lincoln County Growth Policy as guidance for the general policy and pattern of development of Lincoln County, Montana pursuant to Montana Code Annotated Title 76, Chapter 1, Part 1. In 2009 the Board of Commissioners for Lincoln County, Montana adopted the Lincoln 601 et seq; and
- 2. The Lincoln County Planning Board has worked to update the Growth Policy to address current and projected challenges for the betterment of the County's future; and
- 3. Notice of a public hearing on the growth policy update was published in a newspaper of general circulation on August 9, more than 10 days prior to the public hearing as required. by Montana Code Annotated 76-1-602; and
- 4. On August 20, 2019 the Lincoln County Planning Board held a public hearing on the proposed Lincoln County Growth Policy Update; and
- 5. After considering the recommendations and suggestions elicited at the public hearing, at public meeting on September 17, 2019 the Planning Board recommended the Board of Commissioners for Lincoln County adopt the Lincoln County Growth Policy 2019 Update with the amendments listed in Exhibit A of Planning Board Resolution No. 2019-01, and to pursue the goals, actions, and policies therein.

To adopt a Resolution of Intent to adopt the 2019 Lincoln County Growth Policy Update and to pursue the goals, actions, and policies therein.
