A RESOLUTION OF INTENT OF THE BOARD OF COUNTY COMMISSIONERS OF LINCOLN COUNTY, MONTANA TO ADOPT THE LINCOLN COUNTY COMPREHENSIVE ECONOMIC DEVELOPMENT STRATEGY 2019 UPDATE.

THE BOARD OF COMMISSIONERS FOR LINCOLN COUNTY, MONTANA FINDS:

1. It is in the interest of the citizens of Lincoln County to foster the creation of a diverse economy in order to sustain vibrant, healthy communities for present and future generations; and
2. Development of a comprehensive economic development strategy assists businesses and community leaders to focus efforts on opportunities that will enhance the lives of Lincoln County residents; and
3. Keeping Lincoln County's Comprehensive Economic Development Strategy current and relevant places the County favorably in competitions to secure or leverage funding to implement community and economic development projects as identified herein.

THE BOARD RESOLVES:

To adopt a Resolution of Intent to adopt the Lincoln County Comprehensive Economic Development Strategy 2019 Update to position Lincoln County, its businesses and community service providers to take advantage of opportunities and strategically pursue goals for the improvement of the quality of life of Lincoln County residents.
