Resolution 2019-20

A RESOLUTION AUTHORIZING COUNTY TREASURER TO WAIVE DELINQUENT TAXES OF ABANDONED/OR UNINHABITABLE (JUNK) MOBILE HOMES.

THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY, MONTANA FINDS:

1. The Lincoln County Solid Waste Management District allows the disposal of abandoned and/or uninhabitable structures such as mobile homes, camp trailers, titled and taxed personal or real property at Lincoln County Landfill;
2. The purpose of this program is to provide for proper disposal of such structures for owners that can be safely transported intact to the Lincoln County Landfill;
3. In order to qualify for this program, a Mobile Home Moving Permit shall be obtained from the Lincoln County Treasurer's Office and proof that all current and delinquent taxes are paid from the County where property was taxed shall be provided;

THE BOARD RESOLVES:

1. That the Lincoln County Treasurer is hereby authorized to waive delinquent taxes on junk mobile homes in order to obtain a 40-day moving permit for proper disposal to the Lincoln County Landfill per 15-24-206 MCA.

THE BOARD FURTHER RESOLVES:

1. If a provision of this resolution conflicts with a provision of a previously adopted resolution, this resolution will prevail.
2. This resolution and its various sections, clauses and paragraphs are severable. If any part, sentence, clause or phrase is adjudged to be unconstitutional or invalid, the remainder of the resolution will not be affected.
3. This resolution will be effective immediately upon adoption, in accordance with § 7-5-123, MCA.
