Resolution 2022-20

A RESOLUTION REQUESTING DISTRIBUTION OF BRIDGE AND ROAD SAFETY AND ACCOUNTABILITY PROGRAM FUNDS

THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY, MONTANA FINDS:

1. The Bridge and Road Safety and Accountability Account created by HB 473 requires the Montana Department of Transportation to allocate accrued funds to cities, towns, counties, and consolidated city-county governments for construction, reconstruction, maintenance, and repair of rural roads, city or town streets and alleys, bridges, or roads and streets that the city, town, county, or consolidated city-county government has the responsibility to maintain; and,
2. A city, town, county, or consolidated city-county government that requests funds under the Bridge and Road Safety and Accountability Account must match each \$20 requested with \$1 of local government matching funds; and,
3. A city, town, county, or consolidated city-county government requesting distribution of allocated funds may make such a request to the Department of Transportation between March 1 and November 1 of the year the funds were allocated; and,
4. A description of the projects to be funded (or the money used to match federal funds) are detailed in Appendix A; and,
5. The local match for the allocated funds has been budgeted from Fund Number 2110, Lincoln County Road Fund.

THE BOARD RESOLVES:

Lincoln County requests distribution of its share of the allocated Bridge and Road Safety and Accountability funds to be used for the projects identified in Appendix A.

That Wendy Drake, the Lincoln County Finance Director of Lincoln County Montana is hereby empowered and authorized to execute such further documents as may be necessary to facilitate the distribution of said funds.

McGinnis Meadows Road Project

Improvement project consists of Grader and or Dozer scarifying of 8 tenths mile of unusable chip seal surface with new 18 inch culvert placement. Ditch improvements to sustain said culverts. Placement of 2 inch lift of ¾ inch minus crush subgrade material for a 1 ½ inch asphalt overlay on said 8 tenths mile of resurface. 8.0 mile to 8.8 mile mark.

Materials Estimate

1815 tons ¾ inch minus crush for 2 inch subgrade surface @ \$7.10 per ton = \$ 12,886.50

2304 tons ¾ inch minus for chip seal aggregate material @ \$ 7.10 per = \$16,358.50

6 tanker loads HF150 chipping oil @ \$ 27,721.00 per tanker = \$166,326.00

15- 18 inch x 24 ft metal culvert pipe @ \$31.05 per ft= \$11,178.00

10- 18 inch bands @ \$ 56.10 per band = \$ 561.00

Total amount of \$ 207,310.00

Equipment Designate

1 Chip spreader- for 6 days with 8hr avg. per day @ \$ 120.00 hourly rate= \$ 5,760.00

1 Oil distributor- for 6 days with 9hr avg. per day @ \$120.00 hourly rate= \$6,480.00

1 Motor grader- for 5 days with 7hr avg. per day @ \$ 120.00 hourly rate=\$4,200.00

1 Roller/ compactor- for 6 days with 5hr avg. per day @ \$ 80.00 hourly=\$ 2,400.0

1 Excavator- for 7 days with 8hr avg. per day @ \$ 115.00 hourly rate=\$ 6,440.00

1 Dozer- for 2 days with 6hr avg. per day @ \$ 80.00 hourly rate= \$960.00

1 Loader- for 21 days with 3hr avg. per day @ 80.00 hourly = \$ 5,040.00

4 Dump trucks- for 21 days with 9hr avg. @ \$ 100.00 hourly rate = \$75,600.00

Total amount of \$106,880.00
