## Lincoln County Study Commission Minutes of August 13, 2015

The Lincoln County Study Commission met for a regularly scheduled meeting on Thursday, August 13, 2015 at 5:00 pm. The meeting was held in the County Commissioners office in Libby. Commissioner Greg Larson attended in Libby. Chairman Steve Curtiss, Member Bobbie Stoken and Member Josh Letcher attended via satellite in Eureka.

Meeting was called to order at 5:07pm.

Minutes of last meeting were discussed. One correction was noted; remove "charter" and insert "can be done with commissioner form of government." Bobbie motioned to accept minutes as written with the one noted correction. Josh seconded and the motion was passed.
