LINCOLN COUNTY ELECTIONS

Polling Place Locations

THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY, MONTANA FINDS:

WHEREAS, Per MCA 13-3-105, the Board of County Commissioners has the authority to designate polling places for each precinct within the county.

WHEREAS, polling place locations are based on careful consideration of the following criteria (See Exhibit A):

- Increased Ballot Security
- Less Ballot Transports
- Number of electors within the precinct
- Number of absentee electors within the precinct
- Distance between polling locations
- Accessibility / ADA Compliance
- Election Judge Participation

WHEREAS, polling place locations need to be large enough to allow for social distancing.

WHEREAS, the absentee voter percentage has increased dramatically. Lincoln County has a 59% absentee rate that is steadily increasing.

WHEREAS, the Election Department has determined that Lincoln County polling locations are large enough to accommodate all polling place voters.

THE BOARD RESOLVES:

Lincoln County designated polling places are:

- 1. Eureka High Road Youth Center, 1295 2nd Ave. E. Precincts 1, 2, 3, 4
- 2. Troy Troy Activity Center, 380 N 4th Street Precincts 5, 6, 7, 8, 14
- 3. Libby Memorial Center, 111 E. Lincoln Blvd. Precincts 9, 10, 11, 12, 13





THE BOARD FURTHER RESOLVES:

- 1. If a provision of this resolution conflicts with a provision of a previously adopted resolution, this resolution will prevail.
- 2. This resolution and its various sections, clauses and paragraphs are severable. If any part, sentence, clause or phrase is adjudged to be unconstitutional or invalid, the remainder of the resolution will not be affected.
- 3. This resolution will be effective immediately upon adoption, in accordance with § 7-5-123, MCA.
- 4. This Board directs that this resolution be entered into the minutes and signed by the Chair of the Board in accordance with § 7-5-121, MCA.
