RESOLUTION OF INTENT FOR ANNEXATION

THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY, MONTANA FINDS:

1. The Lincoln County Rural Fire District submitted a petition for inclusion into its fire district on May 25, 2022, said property as being shown on attached Exhibit "A"; and
2. The property listed in the application has been verified as being within the proposed area for annexation and requirements pursuant to MCA 7-33-2125(a) have been met; and
3. The Lincoln County Board of Commissioners does approve and pass RESOLUTION 2022-14 INTENT FOR ANNEXATION to annex the property as shown on Exhibit "A" into the Lincoln County Rural Fire District.; and
4. Pursuant to 7-33-2125 MCA, a public hearing will be scheduled with the NOTICE OF PUBLIC HEARING published pursuant to 7-1-2121 MCA.

THE BOARD RESOLVES:

To approve Resolution 2022-14 Intent for Annexation, with a PUBLIC HEARING scheduled on June 22, 2022 at 9:30 AM in the Commissioner's Office located at 512 California Avenue, Libby, Montana to hear protests and comments relating to the proposed annexation.

THE BOARD FURTHER RESOLVES:

1. If a provision of this resolution conflicts with a provision of a previously adopted resolution, this resolution will prevail.
2. This resolution and its various sections, clauses and paragraphs are severable. If any part, sentence, clause or phrase is adjudged to be unconstitutional or invalid, the remainder of the resolution will not be affected.
3. This resolution will be effective immediately upon adoption, in accordance with § 7-5-123, MCA.

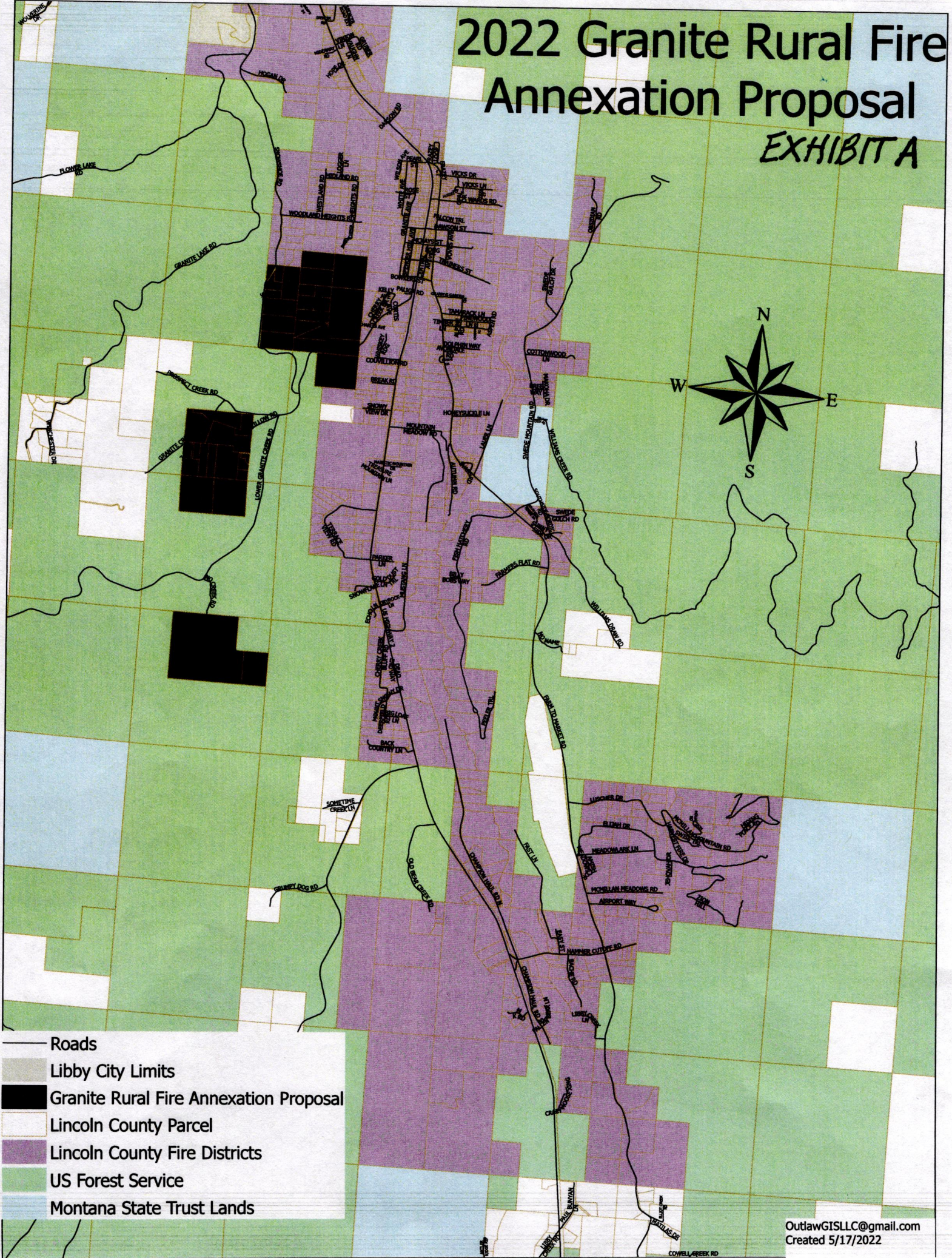
