RE: Septic Installer License Revocation

Mr. Riley,

This letter is to notify you that the Lincoln County Health Department (Department) has revoked your Lincoln County Wastewater Treatment and Disposal System Installer's License (#147). Per Lincoln County Wastewater Treatment and Disposal Regulation 3.2.103(6):

Installer licenses are the property of the Department and may be revoked by the Department at any time for the following reason: Failure to gain approval for a wastewater treatment and disposal system installation.

On September 28, 2020, a permit was issued for 515 Brookie Way, Libby. This permit lists you as the licensed installer. The system was not installed in the approved and permitted location. A notice of violation was issued November 13, 2022. As of today, this violation has not been corrected.

On October 31, 2022, a permit was issued for 120 Nores Lane, Libby. This permit lists you as the licensed installer. The system was inspected and found to be installed incorrectly. The drainfield laterals were installed without the minimum separation of at least five feet between trench walls of gravity-fed trenches required in Circular DEQ 4 6.1.3.3. The City-County Board of Health for Lincoln County granted a variance for this system on January 12, 2023.

On July 26, 2022, a permit was issued for 316 Tamarack Lane, Libby. This permit lists you as the licensed installer. The system was inspected and found to be installed without the required minimum horizontal setback to property lines which is a violation of Lincoln County Wastewater Treatment and Disposal Regulation 3.2.106(b). You have requested a variance from the City-County Board of Health for Lincoln County for this system.

Your license is revoked until you pass the required septic installer license examination with a score of at least 85%. The exam fee is \$150. It is unlawful for you to install, construct, alter, extend, or repair a wastewater treatment and disposal system within Lincoln County until you are relicensed.

You have the right to appeal this decision as outlined in the Lincoln County Notices of Violation & Abatement Order Review Process.
