    - Jenn McCully gave an update on communicable disease. She also gave the board an update on what different programs and services the public health program has been providing across the county.

#### Environmental Health

- Personnel changes
  - Kathi let the board know that Jesse Haag will be moving to the courthouse to be a full time County Planner and Floodplain Administrator. Robin Blumberg will be taking over the sanitarian position at the health department.
- Air Quality Update
  - Kathi spoke about the EPA lowering the annual pm 2.5 standard which may put the Libby area back into non-attainment.

- Recycling Update
  - Kathi said Evergreen Disposal is no longer accepting paper. They are looking for another broker for their recycling products. They will still accept cardboard, aluminum cans and steel cans.
- Expansion Update
  - O Bryan Alkire, Landfill Manager, said they completed the well drilling for the expansion. They are in the middle of doing well development which consists of pumping the water out of the wells until they are clear of all silt. There is a meeting with Great West on March 22<sup>nd</sup> to go over the master plan for the landfill.
