

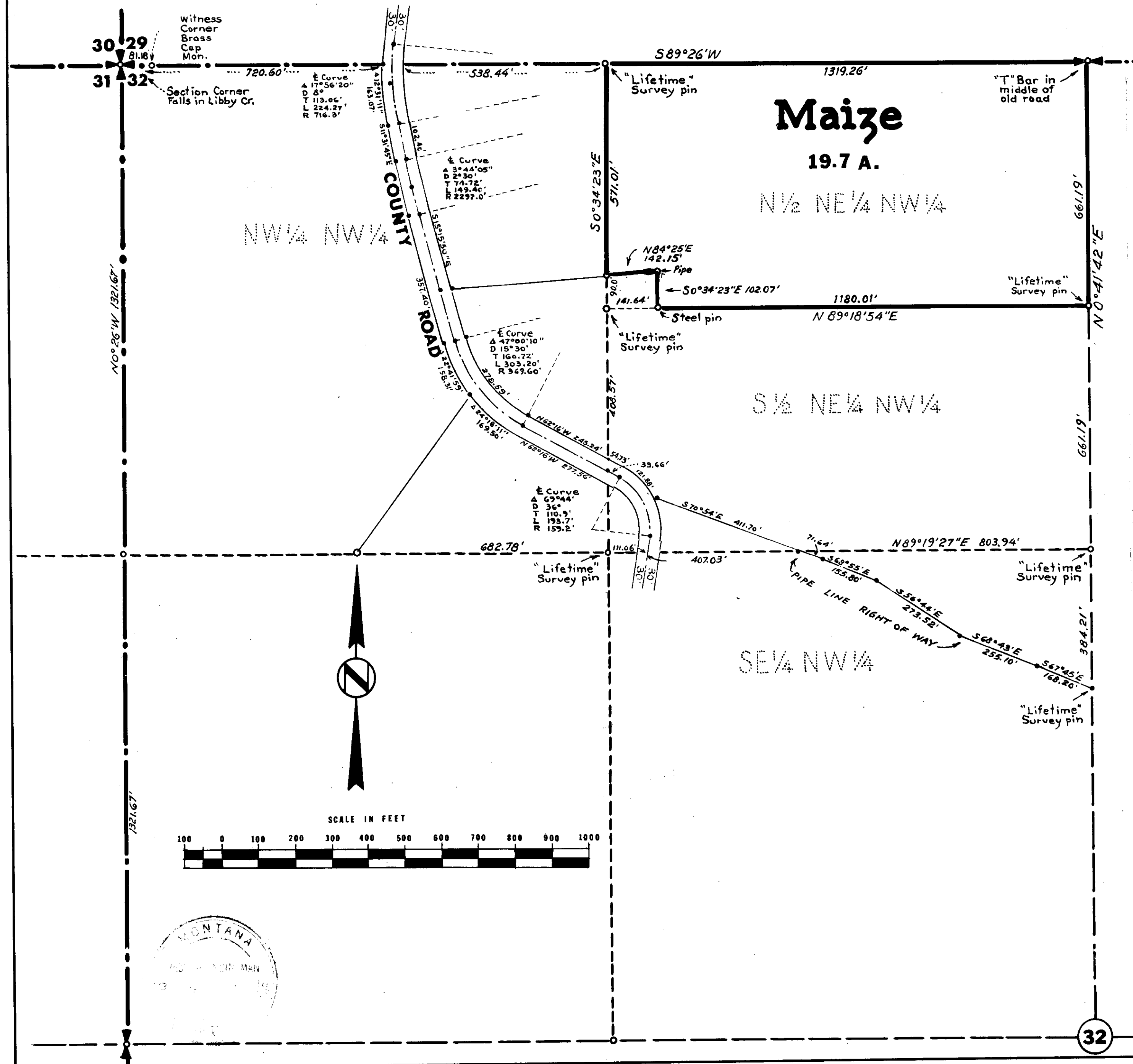

Maize Tract

In the N $\frac{1}{2}$ NE $\frac{1}{4}$ NW $\frac{1}{4}$ Section 32 Twp. 29 N., R. 30 W., M.P.M.



DESCRIPTION

A tract of land near Libby, in Lincoln County, Montana, lying within the N $\frac{1}{2}$ NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 32 Twp. 29 N., R. 30 W., M.P.M., containing 19.7 acres, more or less, and more particularly described as follows: Beginning at the steel "T" Bar (in the middle of an old road) marking the North $\frac{1}{2}$ Corner of Section 32 Twp. 29 N., R. 30 W., M.P.M.; thence, along the north line of said Section 32, S 89°26' W 1319.26 feet to a "Lifetime" Survey pin marking the northwest corner of the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of said Section 32; thence, along the west line of said NE $\frac{1}{4}$ NW $\frac{1}{4}$, S 0°34'23" E 571.01 feet to a steel pin; thence N 84°25' E 142.15 feet to a steel pipe; thence S 0°34'23" E 102.07 feet to a steel pin; thence N 89°18'54" E 1180.01 feet to a "Lifetime" survey pin marking the southeast corner of the N $\frac{1}{2}$ NE $\frac{1}{4}$ NW $\frac{1}{4}$ said Section 32; thence, along the north-south centerline of said Section 32, N 0°41'42" E 661.19 feet to the point of beginning.

Access to the afore described tract provided by reservation of a thirty foot strip, from the County Road, generally north-erly through the tract adjacent on the south and west, as recorded in Contract For Deed, Micro-film Book 21 Page 790 Lincoln County Records.
