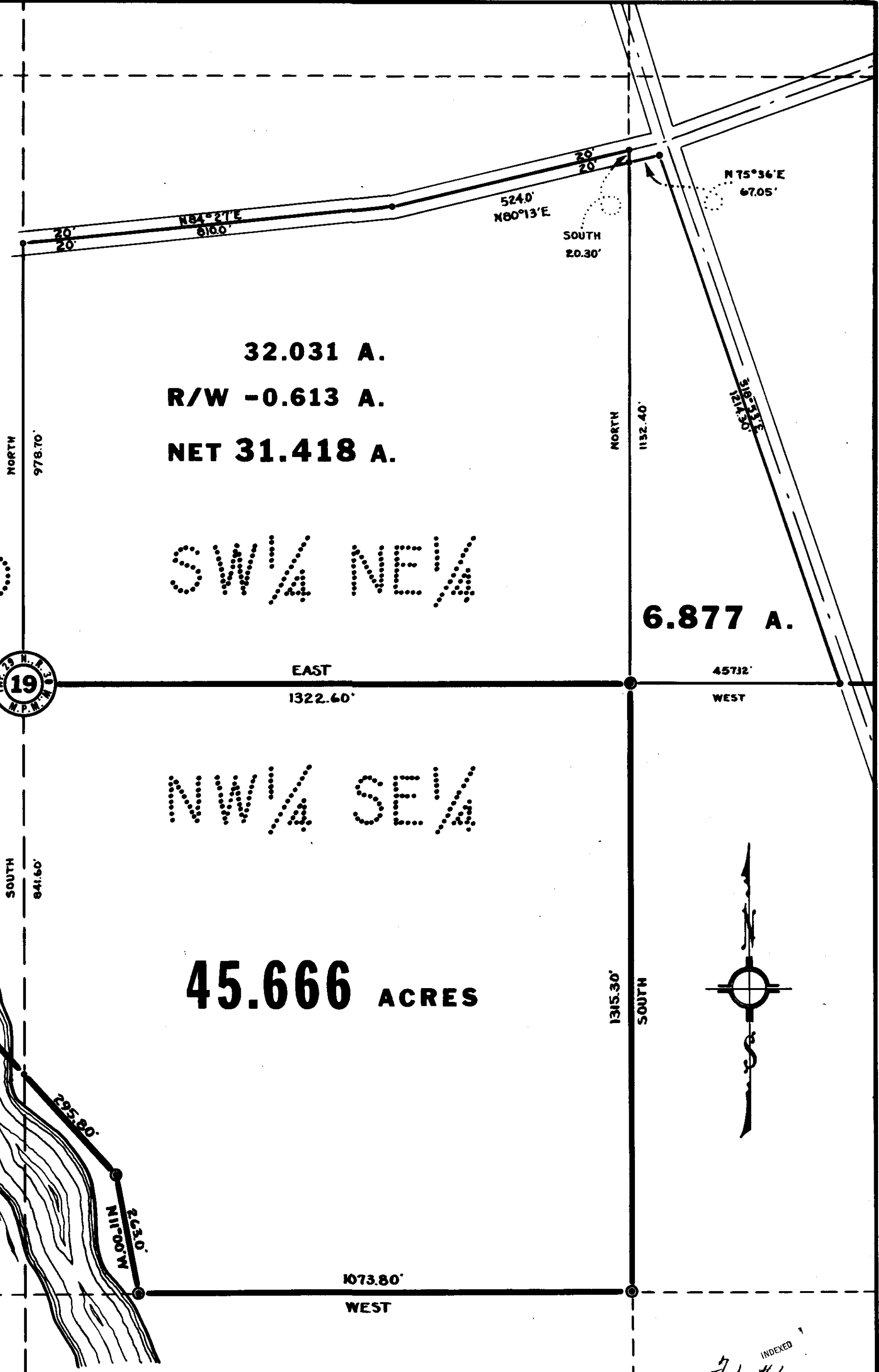
**DESCRIPTION**  
An irregular tract of land near Libby in Lincoln County, Montana, lying wholly within the NW 1/4 SE 1/4 and the NE 1/4 SW 1/4 of Section 19 Twp. 29 N., R. 30 W., M.P.M., containing 45.636 acres, more or less, and more particularly described as follows:  
Beginning at the Center, Corner of Section 19 Twp. 29 N., R. 30 W., M.P.M.; thence, along the east-west centerline of said Sec. 19, East 1322.60 feet to the northeast corner of the NW 1/4 SE 1/4 of said Sec. 19; thence, along the east line of said NW 1/4 SE 1/4, South 1315.30 feet; thence, along the south line of said NW 1/4 SE 1/4, West 1073.80 feet; thence, along approximate creek channel, N 11° 00' W 263.0 feet; thence, along same channel N 42° 33' W 295.80 feet to a point on the north-south centerline of said Sec. 19, which point lies South 841.60 feet from the center, Corner of said Sec. 19; thence continuing N 42° 33' W 1145.10 feet to a point on the east-west centerline of said Sec. 19; thence, along said east-west centerline, East 772.50 feet to the point of beginning.
