


# CERTIFICATE OF SURVEY



## DESCRIPTION

A tract of land located in the SW $\frac{1}{4}$  SW $\frac{1}{4}$  of Section 25, T35N, R26W, M.P.M., Lincoln County, Montana, more commonly described as follows, to-wit:  
Commencing at an I.P. inscribed #270ES, said I.P. being the west sixteenth corner of the SW $\frac{1}{4}$  of said Section 25, thence S85°E 379' to an I.P. inscribed #270ES, thence S50°28'12"E 82.69' to an I.P. inscribed #270ES, and the point of beginning of the herein described tract, thence S52°29'53"E 25.76' to an I.P. inscribed #270ES, thence S64°59'53"E 175' to an I.P. inscribed #270ES, thence S54°59'53"E 378' to an I.P. inscribed #270ES, thence S45°59'49"E 520' to an I.P. inscribed #270ES, said I.P. being the south property corner of the herein described tract, thence N00°08'49"W 203.26' to an I.P., thence N89°57'49"W 165' to an I.P., thence N00°02'11"E 264' to an I.P., thence N89°57'49"W 166' to an I.P., thence N00°02'11"E 264' to an I.P., said I.P. located on the south right-of-way line of Meadow Creek Road, said right-of-way being 60'-0" wide, thence along said Meadow Creek Road south right-of-way line S85°27'08"W 306.46' to an I.P. inscribed #270ES, thence S89°13'18"W 247.51' to an I.P. inscribed #270ES, thence S04°38'23"E 57.58' to the point of beginning, containing 4.354 acres.
