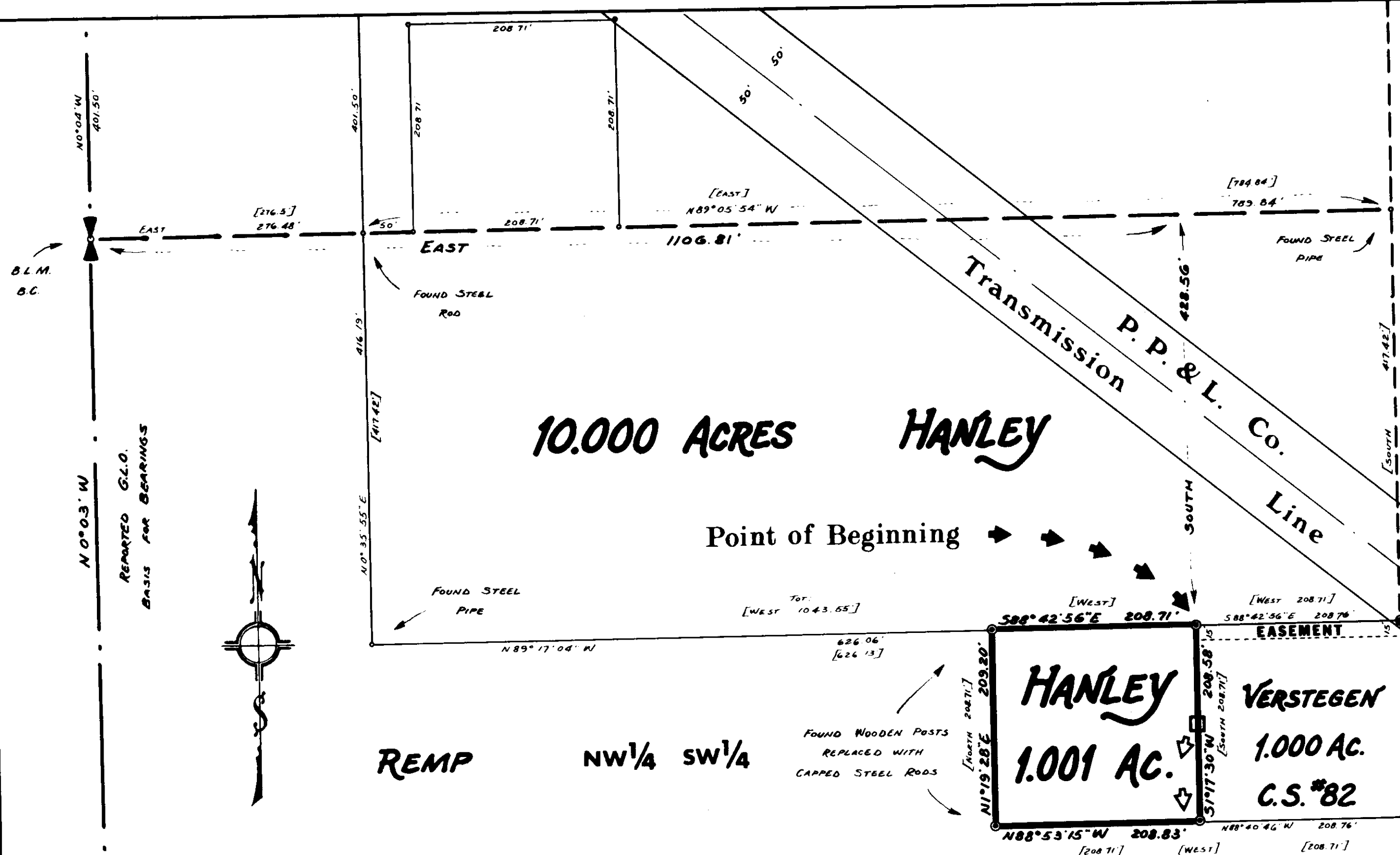

CERTIFICATE OF SURVEY

IN THE NW¹/₄ SW¹/₄ OF SECTION 34
TWP. 31 N., R. 31 W., M.P.M.

JULY, 1976



DESCRIPTION

A regular tract of land near Libby in Lincoln County, Montana, lying wholly within the NW¹/₄ SW¹/₄ of Section 34 Twp. 31 N., R. 31 W., M.P.M., containing 1.001 acre, more or less, and more particularly described as follows: Beginning at a point East 1106.81 feet and South 428.56 feet from the west 1/4 Corner of Section 34 Twp. 31 N., R. 31 W., M.P.M.; thence, S 17°30' W 208.58 feet; thence, N 88°53'15" W 208.83 feet; thence, N 19°28' E 209.20 feet; thence, S 88°42'56" E 208.71 feet to the point of beginning.

INCLUDING an easement for ingress and egress over a strip of land 15 feet in width along the north line through adjacent 1.000 acre tract to the east as shown hereon.

BASIS FOR BEARINGS

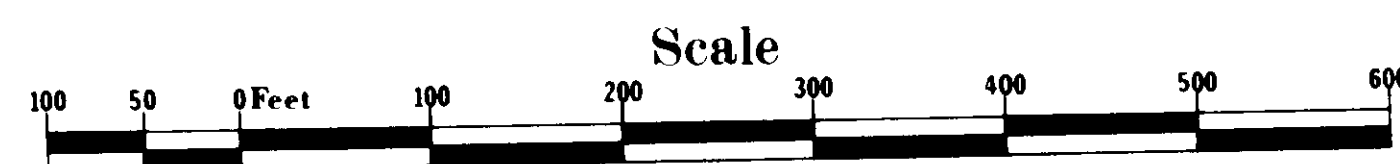

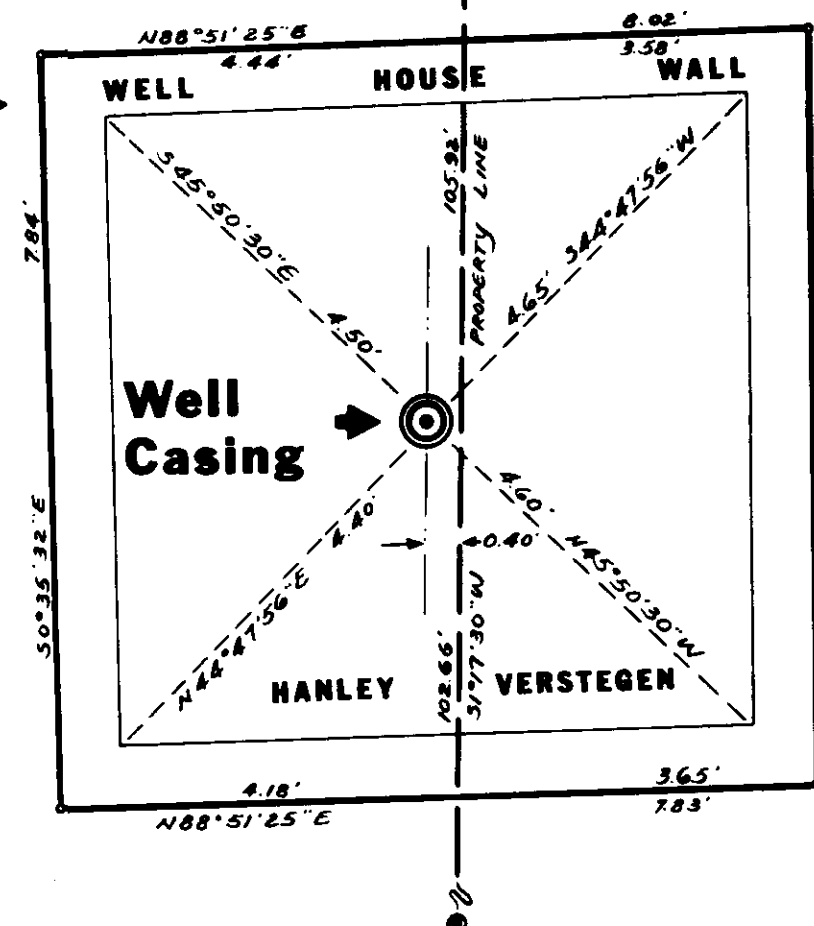
