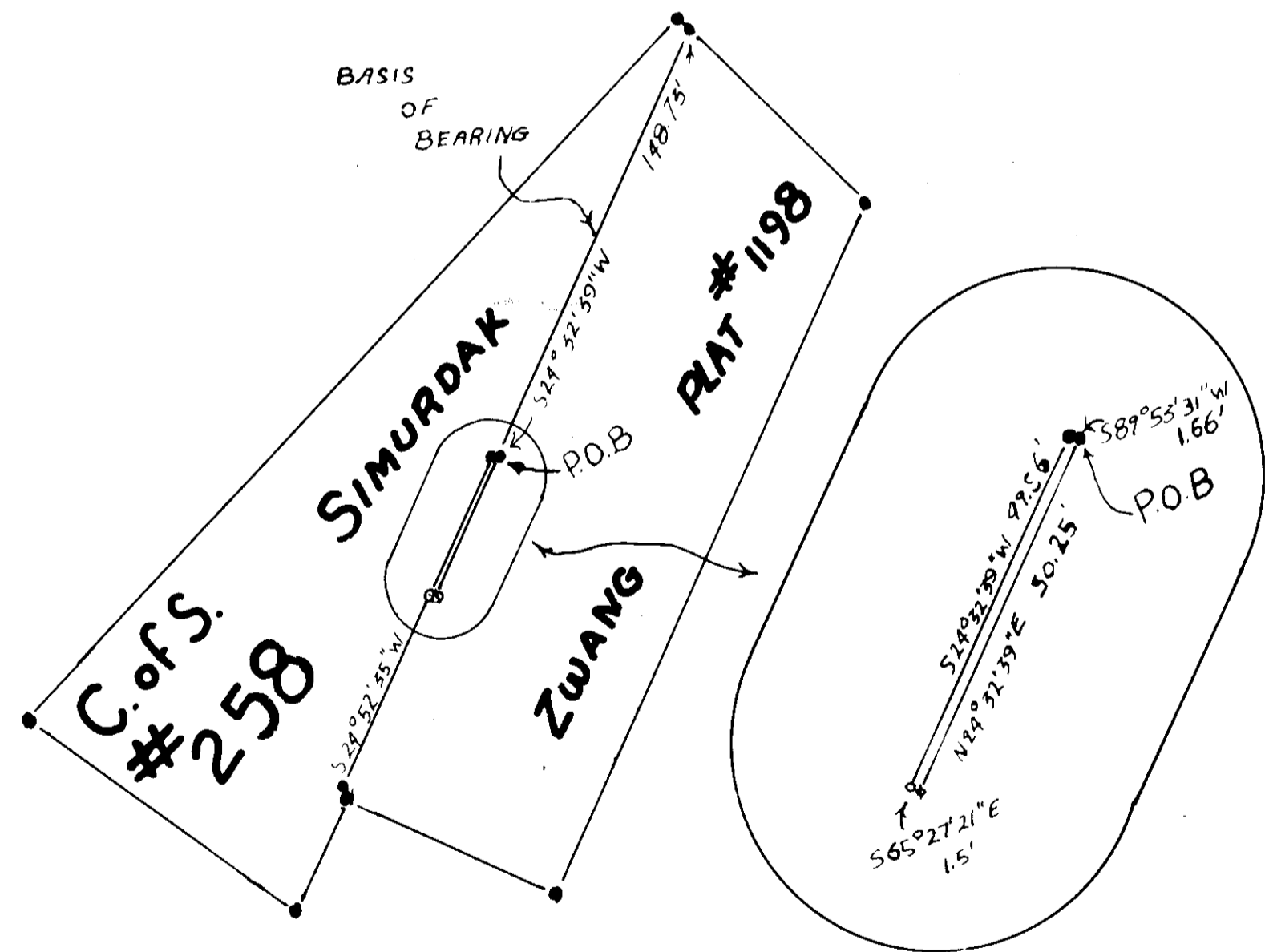

Beginning at a found iron nail in concrete which bears S 24° 32' 39" W 146.75 feet from the Northwesterly corner of a parcel of land as shown on C.S. No. 258; thence S 89° 52' 51" E 1.5 feet to a found steel pin in concrete; thence S 24° 32' 39" E 49.50 feet to a steel 1/2" pipe tagged 42323; thence S 65° 27' 21" E 1.5 feet to a scribe on the concrete foundation; thence N 24° 32' 39" E 50.25 feet to the point of beginning. This parcel contains .002 acres, more or less.
