CERTIFICATE OF SURVEY

IN THE N/2 SE/4 OF SECTION 7
TWP. 30 N., R. 33 W., M.P.M.

MAY, 1977

DESCRIPTION

An irregular tract of land near Troy in Lincoln County, Montana, lying wholly within the Ni SE of Section 7 Twp. 30 N., R. 33 W., M.P.M., containing 34.511 acres, more or less, and more particularly described as follows:

Beginning at a point on the south line of the N₂ SE₃ of Section 7 Twp. 30 N., R. 33 W., M.P.T., at a distance of 668.52 feet S 89 26 07" W from the southeast corner of said N₂ SE₃, which point of beginning falls in the mid-channel of Lake Creek; thence, from said point of beginning, along said south line, S 89 26 07" W 1430.00 feet to a point on the easterly right of way line of the Lake Creek Road at a distance of 30.0 feet measured at right angles from the centerline thereof; thence, leaving said south line, along said easterly right of way line, N 2019'16" W 310.20 feet; thence, on the arc of a curve to the right having a radius of 1119.74 feet, turning through an angle of 32010'42" a distance of 628.87 feet; thence, N 29 51'26" E 196.26 feet; thence, on the arc of a curve to the left having a radius of 1770.81 feet, turning through an angle of 101'39" a distance of 31.76 feet to a point where the radius bears N 61 10'13" W; thence, leaving said easterly right of way line, parallel to the east-west centerline of said Section 7, N 89 21'03" E 1527.96 feet to a point in the mid-channel of Lake Creek; thence, following, generally, said mid-channel of Lake Creek, upstream, the following five courses: S 28 95.00 feet; thence, S 51 10'17" W 438.91 feet; thence, S 29 12' 15" W 318.60 feet; thence, S 9 E 185.00 feet; thence, S 29 33'17" E 337.94 feet to the point of beginning.

BASIS FOR BEARINGS

Bearings were based on the bearing of the east line of Section 7 Twp. 30 N., R. 33 W., M.P.M. assumed to bear N 0 05 16 W.

PURPOSE OF SURVEY

To locate the boundaries of the subject tract of land to provide for conveyance by reference hereto.
