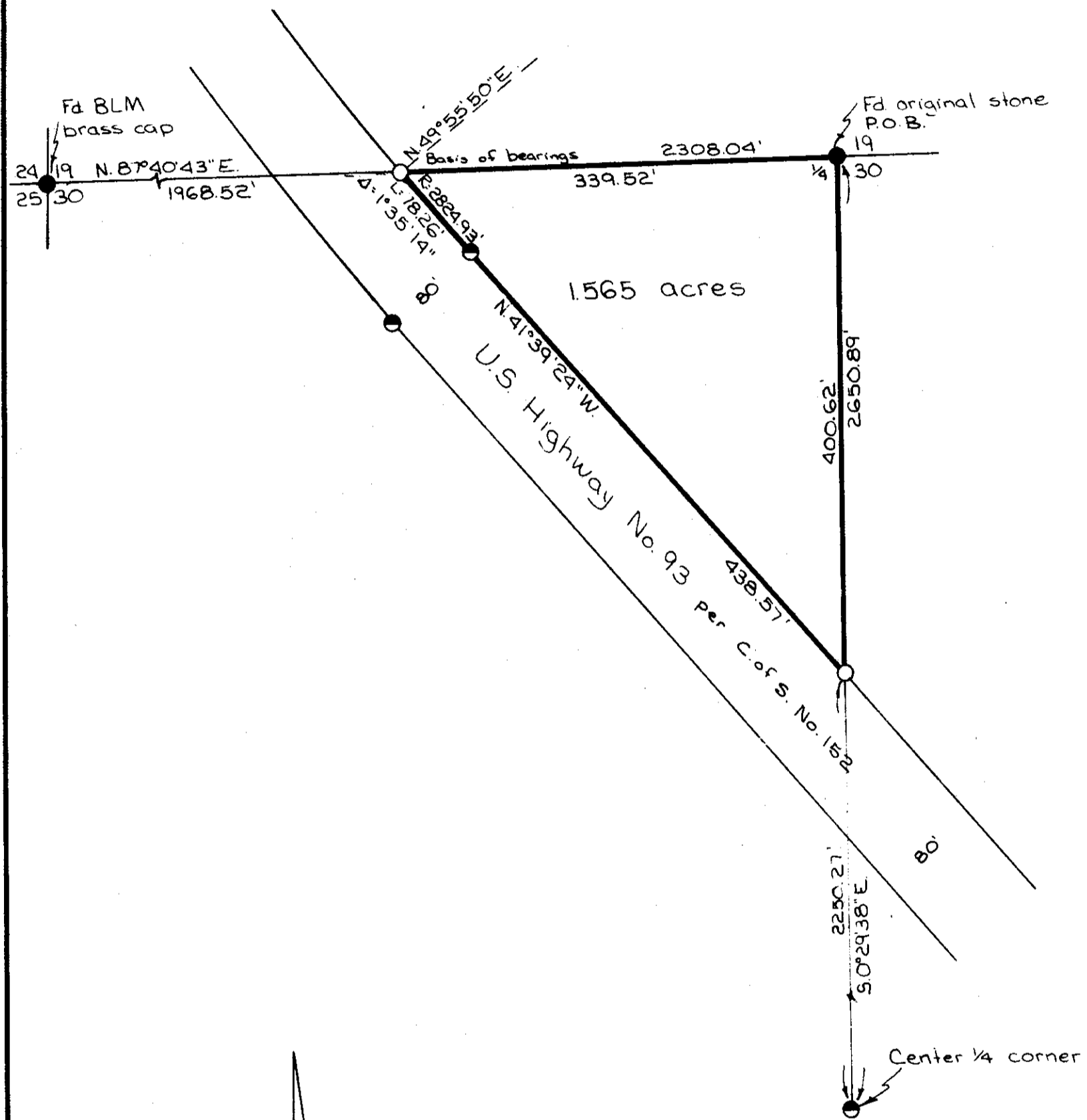

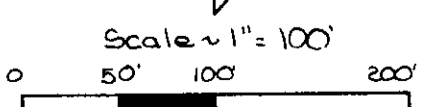

LEGAL DESCRIPTION

THAT PORTION OF THE NORTHWEST 1/4, SECTION 30, TOWNSHIP 36 NORTH, RANGE 26 WEST, LINCOLN COUNTY, MONTANA DESCRIBED AS FOLLOWS:  
 BEGINNING AT THE NORTH 1/4 CORNER OF SECTION 30; THENCE ALONG THE EAST LINE OF THE NORTHWEST 1/4 SOUTH 0°29'38" EAST 400.62 FEET TO THE NORTHEASTERLY LINE OF U. S. HIGHWAY No. 93; THENCE ALONG THE NORTHEASTERLY LINE NORTH 41°39'24" WEST 438.57 FEET TO THE BEGINNING OF A 2824.93 FOOT RADIUS CURVE TO THE RIGHT; THENCE CONTINUING ALONG THE NORTHEASTERLY LINE NORTHWESTERLY ALONG THE CURVE THRU A CENTRAL ANGLE OF 1°35'14" 78.26 FEET TO THE NORTH LINE OF THE NORTHWEST 1/4; THENCE ALONG THE NORTH LINE NORTH 87°40'43" EAST 339.52 FEET TO THE POINT OF BEGINNING, CONTAINING 1.565 ACRES OF LAND.
