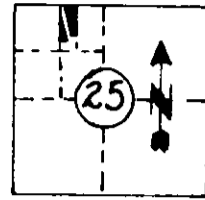


# CERTIFICATE OF SURVEY

### DESCRIPTION

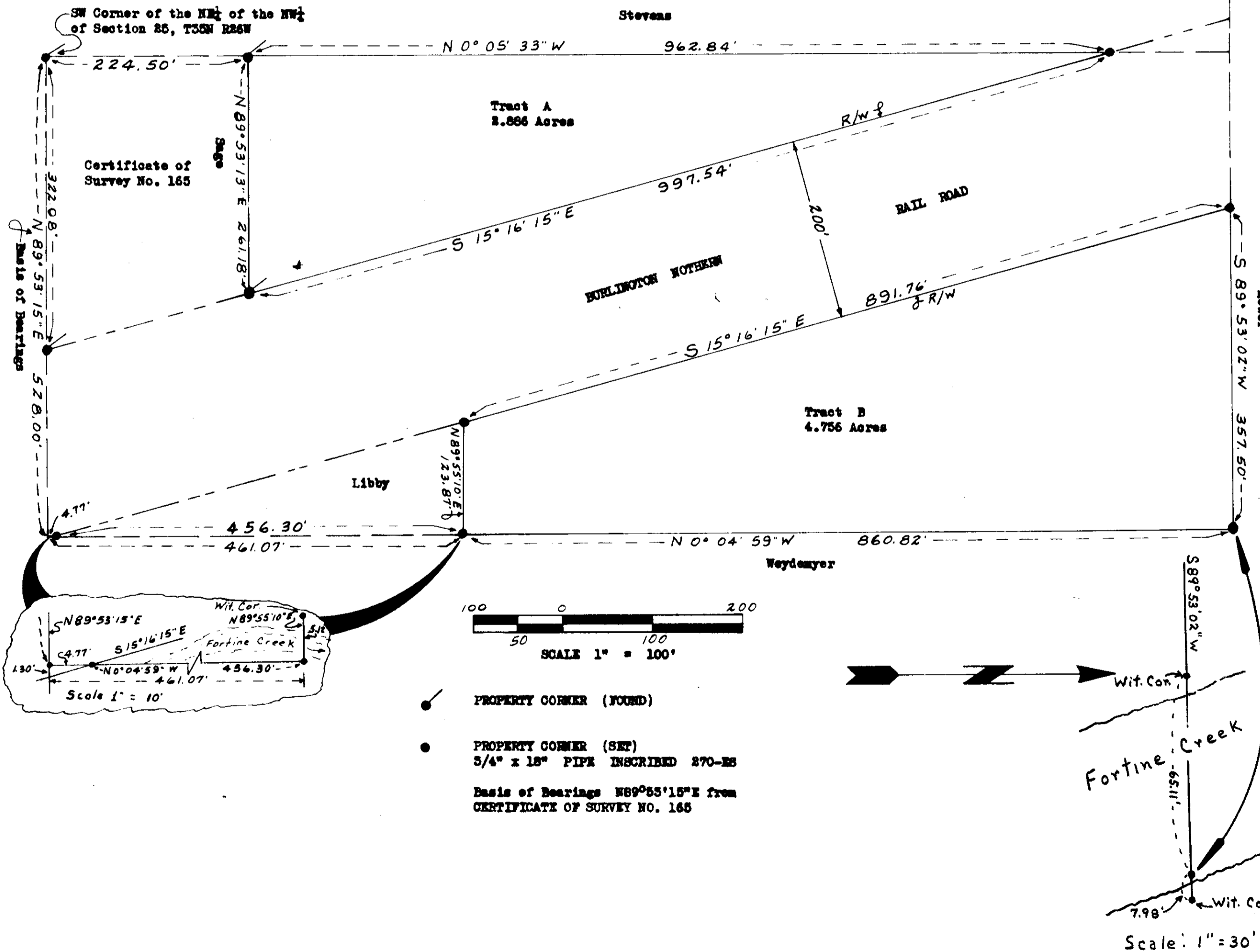
#### TRACT A

A small tract of land in the NE $\frac{1}{4}$  of the NW $\frac{1}{4}$  of Section 25, T36N R26W N.P.M., Lincoln County, Montana, more particularly described as follows:  
Beginning at a point which is N0°05'33"W a distance of 224.50' from the SW Corner of the NE $\frac{1}{4}$  of the NW $\frac{1}{4}$  of section 25, T36N R26W M.P.M.; thence N89°53'13"E 267.18' to Point 48 on the Fortine Right of Way - Adams & Lincoln R.R.; thence S15°16'15"E 997.54', along said R/W line; thence N89°53'15"E 261.18' to the point of beginning, containing 2.886 Acres.

### DESCRIPTION

#### TRACT B

A small tract of land in the NE $\frac{1}{4}$  of the NW $\frac{1}{4}$  of Section 25, T36N R26W N.P.M., Lincoln County, Montana, more particularly described as follows:  
Beginning at a point which is N89°55'15"E a distance of 528.00' and N0°04'59"W a distance of 461.07' from the SW Corner of the NE $\frac{1}{4}$  of the NW $\frac{1}{4}$  of section 25, T36N R26W M.P.M.; thence N0°04'59"W 860.82'; the north line of said section 25; thence S89°55'08"W 357.50', along said section line to the Easterly Right of Way line of the B.M.R.R.; thence S15°16'15"E 891.76', along said R/W line; thence N89°55'10"E 123.87' to the point of beginning, containing 4.756 Acres.
