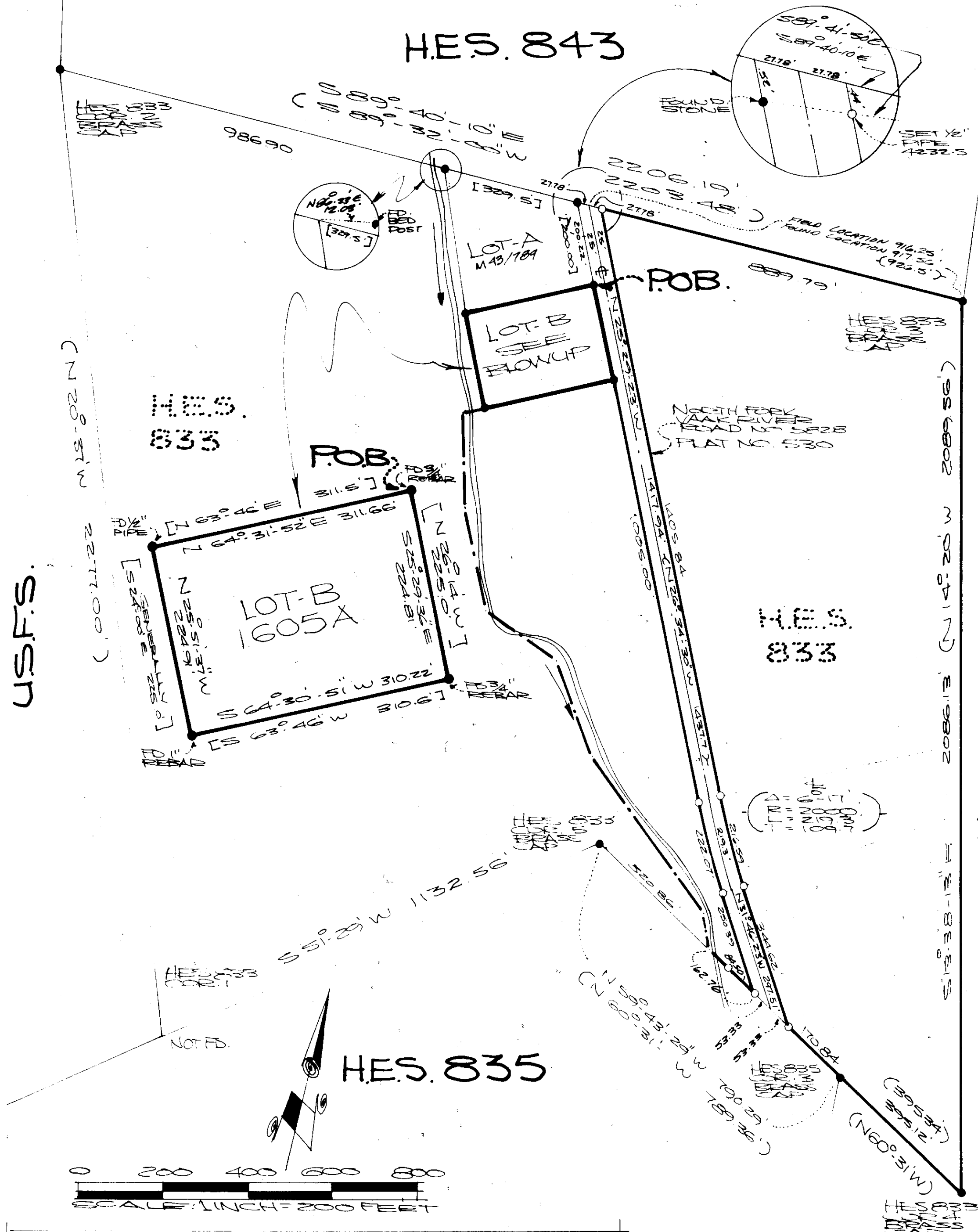


CERTIFICATE OF SURVEY

DESCRIPTION OF LOT B

A parcel of land lying wholly within H.E.S. 833 in Section 22, T37N, R31W, P.M.M.

Beginning at a found 3/4" rebar at the Southeast corner of Lot A per Book 1443 page 189 Lincoln County Records; said point also being on the Westerly right-of-way line of the North Fork Yaak River Road No. 5828; thence S25 27'23"E 224.81 feet along said right-of-way line to a found 3/4" rebar; thence leaving said right-of-way line S64 30'51"W 310.22 feet to a found 1" rebar on the bank of said river; thence N25 51'37"W 224.91 feet to a found 1/2" pipe at the Southwest corner of Lot A; thence N64 31'52"E 311.66 feet along the common boundary between Lots A and B 311.66 feet to the point of beginning. This parcel contains 1.605 acres more or less.
