DESCRIPTION

An irregular tract of land near Troy in Lincoln County, kontana, lying wholly within the NE2 of Section 18 Twp. 30 N., R. 33 W., M.P.M., containing 14.636 acres, more or less, and more particularly described as follows: Beginning at the intersection of the east-west centerline of Section 18 Twp. 30 N., H. 33 W., M.P.M. with the southeasterly right of way line of the Keeler Creek Road at a distance of 25.0 feet measured at right angles from the centerline thereof, which point of beginning lies N 69 36'40" E 145.84 feet from the Center 1/4 Corner of said Section 18; thence, along said southeasterly right of way line, N 26'56' E 448.34 feet; thence, on the arc of a curve to the left having a radius of 2890.0 feet, turning through an angle of 17'57' a distance of 905.40 feet; thence, N 8'59' E 76.64 feet; thence, on the arc of a curve to the right having a radius of 235.5 feet, turning through an angle of 49'00' a distance of 201.40 feet; thence, N 57'59' E 87.74 feet; thence, on the arc of a curve to the right having a radius of 5.0 feet, turning through an angle of 122016' a distance of 10.67 feet to a point on the westerly right of way line of the Lake Creek Road at a distance of 25.0 feet measured at right angles from the centerline thereof; thence, along said westerly right of way line, S 0°15' W 110.49 feet; thence, on the arc of a curve to the left having a radius of 343.3 feet, turning through an angle of 38°37'34" a distance of 231.44 feet to a point where the radius bears N 51 37'26" E; thence, leaving said westerly right of way line, South 1208.09 feet to a point on the east-west centerline of said Section 18; thence, along said east-west centerline, 5 89°36.40" W 756.57 feet to the point of beginning.


