DESCRIPTION

A rectangular tract of land near Libby in Lincoln County, Montana, lying wholly within the NE $\frac{1}{4}$ of Gov't Lot 4 of Section 1 Twp. 29 N., R. 31 W., M.P.M., containing 1.336 acres, more or less, and more particularly described as follows:

Beginning at the northwest corner of the NE $\frac{1}{4}$ of Gov't Lot 4 of Section 1 Twp. 29 N., R. 31 W., M.P.M.; thence, along the north line of said Section 1, S $89^{\circ}54'49''$ E 139.66 feet; thence, leaving said north line, parallel to the east line of the NE $\frac{1}{4}$ of said Gov't Lot 4, S $0^{\circ}16'24''$ E 417.80 feet; thence, parallel to the north line of said Section 1, N $89^{\circ}54'49''$ W 139.00 feet to a point on the west line of the NE $\frac{1}{4}$ of said Gov't Lot 4; thence, along said west line, N $0^{\circ}21'54''$ W 417.80 feet to the point of beginning.

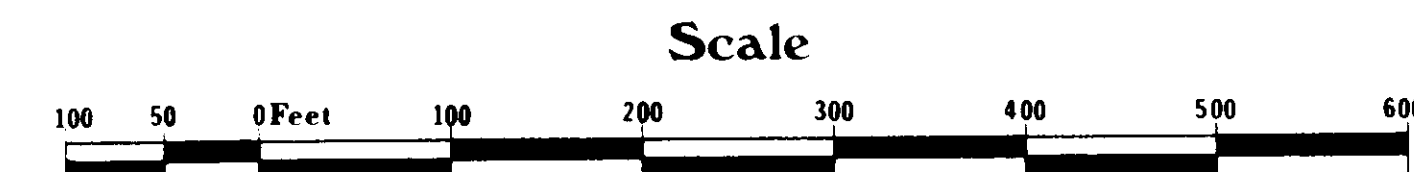
