DESCRIPTION

An irregular tract of land near Libby in Lincoln County, Montana, lying wholly within the Et NE's SE's of Section 29 Twp. 31 N., R. 31 W., M.P.M., containing 0.950 acre, more or less, and more particularly described as follows:

Beginning at the southeast corner of Tract A of Plat No. 1444 of Lincoln County, Montana records on the westerly line of a 50.00 foot wide County Road Right of Way; thence, from said point of beginning, along the south line of said Tract A, S 89°22'41" W 297.05 feet; thence, leaving said south line, parallel to the east line of said Tract A, N 0°11' W 164.86 feet; thence, parallel to the south line of said Tract A, N 89°22'41" N 128.01 feet; thence, S 62°32'55" E 190.80 feet to a point on the east line of said Tract A, also being said westerly right of way line; thence, along said east line and said westerly right of way line, S 0°11' B 75.07 feet to the point of beginning.
