#### DESCRIPTION

Beginning at the northeast corner of Block 1 of the Remp Addition to Libby (a recorded subdivision of Lincoln County, Montana) in Lot 3 of Section 3 Twp. 30 N., R. 31 W., M.P.M.; thence, along the southeasterly line of Block 1 of said Remp Addition, S 24059'00" W 56.00 feet; thence, leaving said southeasterly line, S 69009'00" E 88.15 feet to a point on the northwesterly line of a tract on Plat No. 652 of Lincoln County, Montana records, which point lies on the northwesterly right of way line of a County Road at a distance of 8.00 feet measured at right angles from the centerline thereof; thence, along the northwesterly line of a tract on said Plat No. 652, N 280 36'00" E 49.74 feet; thence, leaving said northwesterly line, along the northeasterly line of Block 1 of said Remp Addition extended southeasterly, N 65001'00" W 91.06 feet to the point of beginning.
