CERTIFICATE OF SURVEY

IN THE NE 1/4 OF SECTION 5
TWP. 33 N., R 34 W., M.P.M.
NOVEMBER, 1978

DESCRIPTION

An irregular tract of land near the Montana Idaho boundary in Lincoln County, Montana, lying wholly within the NE 1/4 of Section 5 Twp. 33 N., R. 34 W., M.P.M., containing 44.717 acres, more or less, and more particularly described as follows:
Beginning at the North 1/4 Corner of Section 5 Twp. 33 N., R. 34 W., M.P.M.; thence, along the north line of said Section 5, S 89° 35' 09" E 1280.26 feet to a point on the northerly end of a north-south fence in the NE 1/4 of said Section 5; thence, along said north-south fence, S 1° 44' 02" E 1916.88 feet to a capped steel rod stamped: J.L. 534 E.S. marking the northeast corner of Certificate of Survey No. 288 of Lincoln County, Montana records; thence, along the northwesterly boundary of said Certificate of Survey No. 288, S 54° 34' 50" W 554.05 feet to the northwest corner thereof on the northeasterly right of way line of Old U. S. Highway No. 2; thence, along said northeasterly right of way line, N 23° 03' 07" W 2266.44 feet to a point on the north-south centerline of said Section 5; thence, along said north-south centerline, N 0° 15' 57" E 160.90 feet to the point of beginning.
SUBJECT to an Access Easement 40.00 feet in width parallel and adjacent to the southeasterly boundary of the afore described tract, referred to as Stewart road, as shown hereon.

PURPOSE FOR SURVEY

To locate the boundaries of the Subject tract of land to provide for conveyance by reference hereto.

BASIS FOR BEARINGS

Bearings were based on the bearing of the north line of Section 5 Twp. 33 N., R. 34 W., M.P.M. assumed to bear S 89° 35' 09" E.

DESCRIPTION REMAINDER

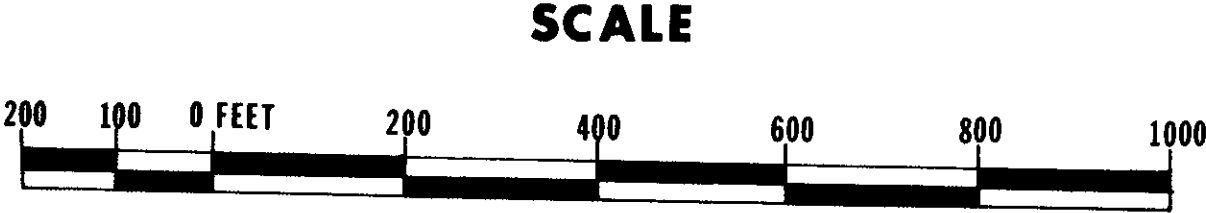
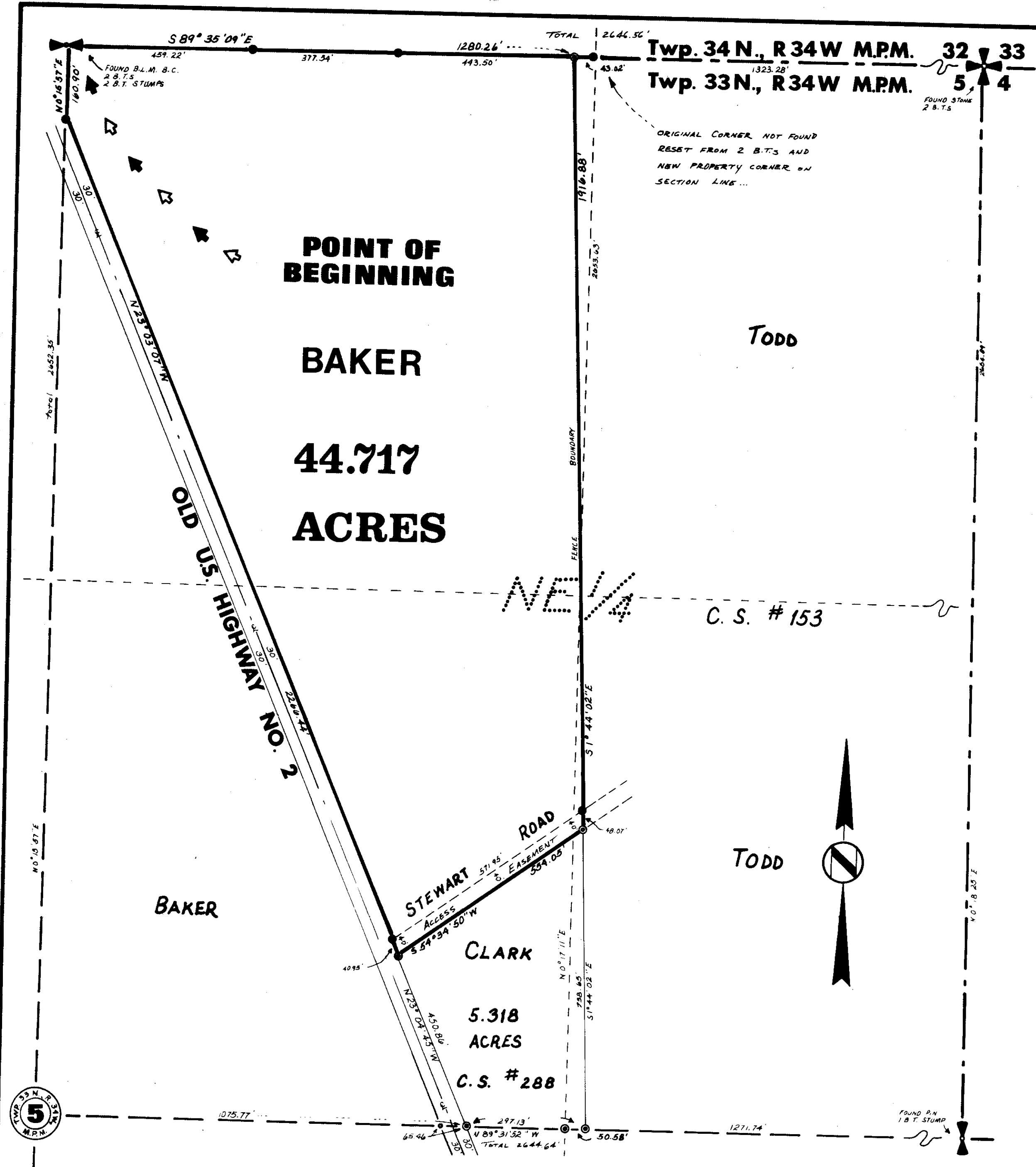
