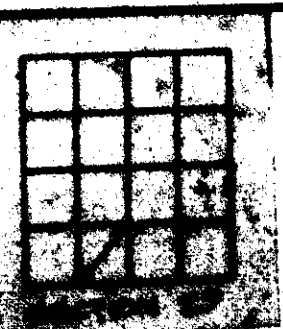

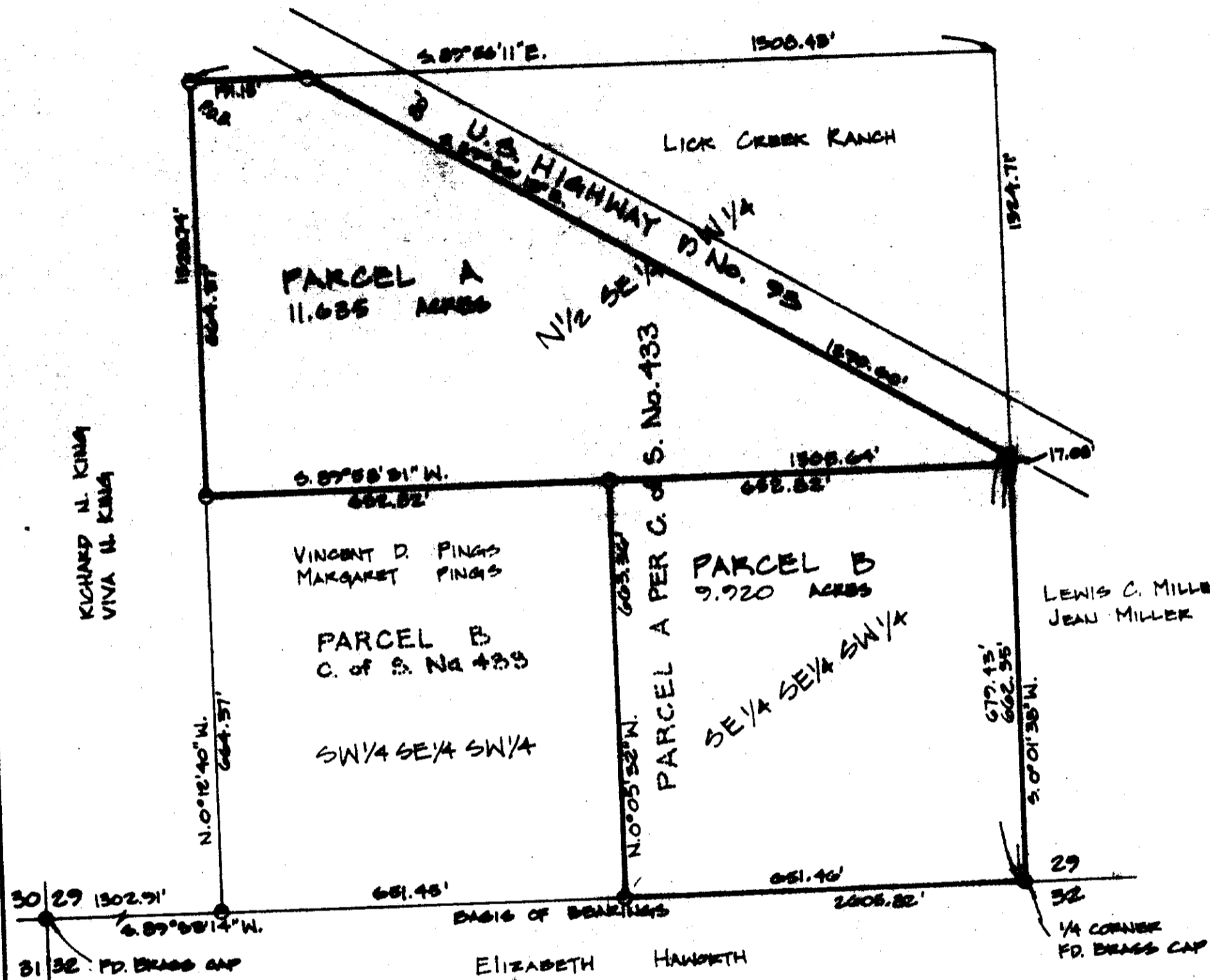

 BEGINNING AT THE NORTHWEST CORNER OF THE SOUTHEAST 1/2 SOUTHWEST 1/4, SECTION 29, ALSO BEING THE NORTHWEST CORNER OF PARCEL A PER CERTIFICATE OF SURVEY No. 433; THENCE ALONG THE NORTH LINE OF THE SOUTHWEST 1/2 SOUTHWEST 1/4, ALSO BEING THE NORTH LINE OF SAID PARCEL A SOUTH 89°56'11" EAST 191.15 FEET TO A POINT ON THE WESTERLY RIGHT OF WAY LINE OF U. S.
