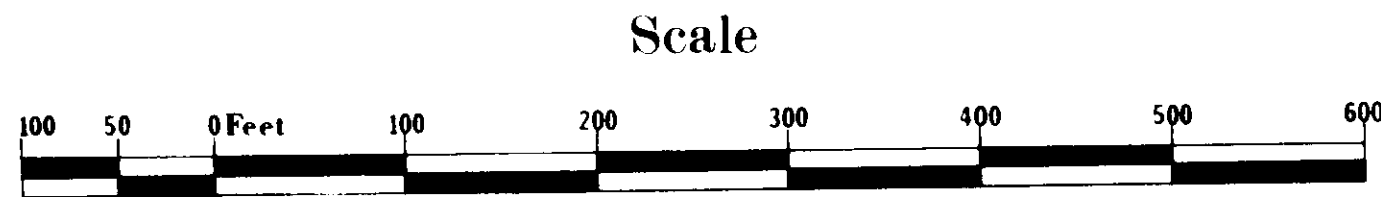
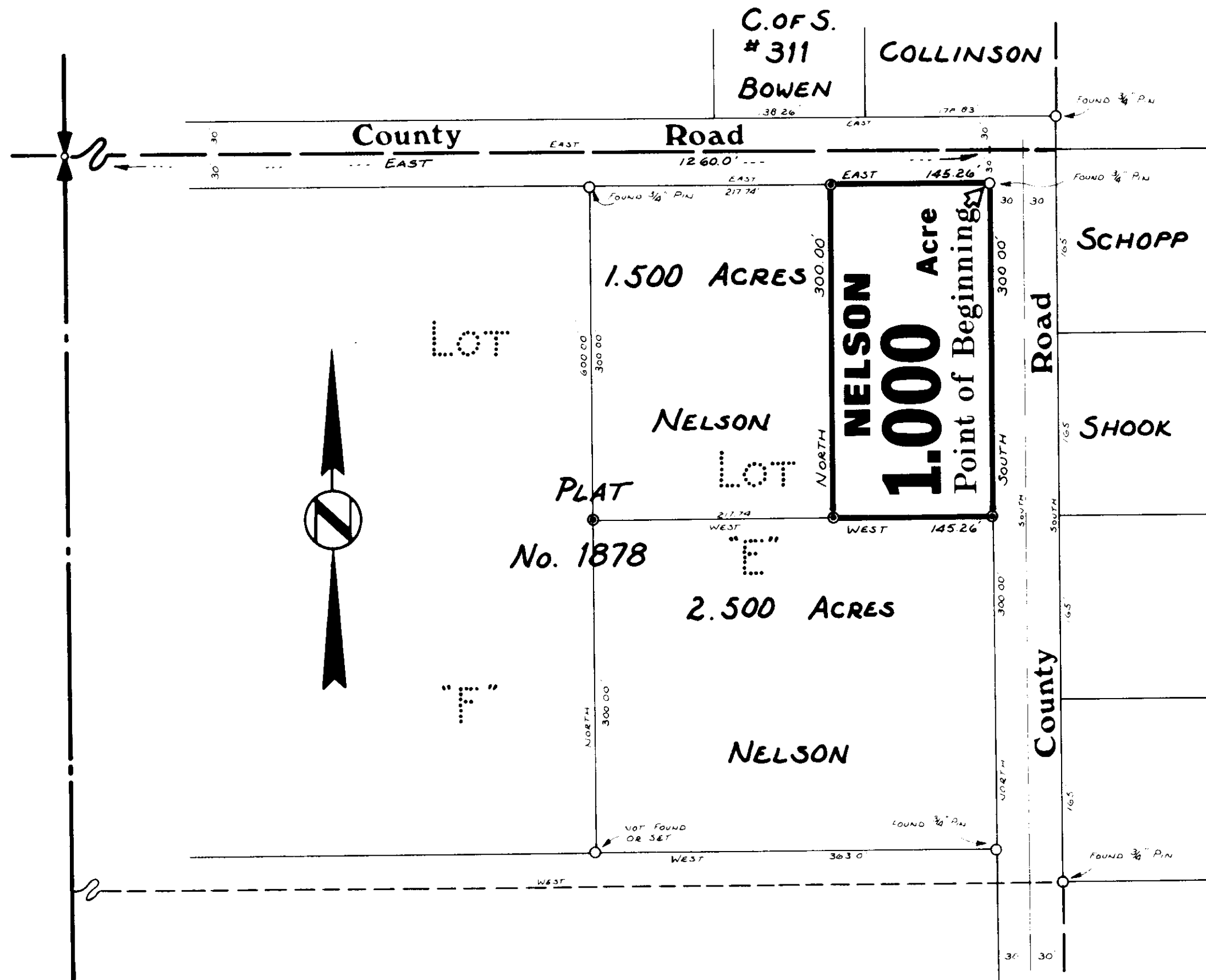

DESCRIPTION

A rectangular tract of land near Libby in Lincoln County, Montana, lying wholly within the N 1/2 NW 1/4 SW 1/4 of Section 25 Twp. 30 N., R. 31 W., M.P.M., containing 1.000 acre, more or less, and more particularly described as follows:

Beginning at the point of intersection of the southerly and westerly right of way lines of a County Road at a distance of 30.00 feet measured at right angles from the centerlines thereof, which point of beginning lies East 1260.00 feet and South 30.00 feet from the West 1/4 Corner of Section 25 Twp. 30 N., R. 31 W., M.P.M.; thence, from said point of beginning, along the westerly right of way line of said County Road, South 300.00 feet; thence, leaving said westerly right of way line, West 145.26 feet; thence, North 300.00 feet to a point on the southerly right of way line of said County Road; thence, along said southerly right of way line, East 145.26 feet to the point of beginning.
