DESCRIPTION

An irregular tract of land located in the NW 1/4 of the NE 1/4 of Section 13, T29N, R31W, P.M.M., near Libby, Montana.

Beginning at a found B.L.M. brass cap which is the N 1/4 corner of Section 13, T29N, R31W, P.M.M.; thence, along the north line of the NW 1/4 of the NE 1/4 of said Section 13, S88°48'19"E 1268.25 feet to a found 1/2 inch pipe; thence, leaving said north line S88°48'19"E 1268.76 feet along the east line of said NW 1/4 of the NE 1/4 to a point; thence, leaving said east line N75°50'16"E 714.51 feet to a set 5/8 inch rebar tagged MDL 4232-S; thence, S87°30'12"E 371.70 feet to a set 5/8 inch rebar tagged MDL 4232-S located on the eastern right of way line of a 60.00 foot wide private road; thence, along said right of way line N15°31'19"E 700.00 feet to a set 5/8 inch rebar tagged MDL 4232-S; thence, leaving said right of way line and along the west line of the aforementioned NW 1/4 of the NE 1/4 N1°31'17"E 486.13 feet to the point of beginning.
