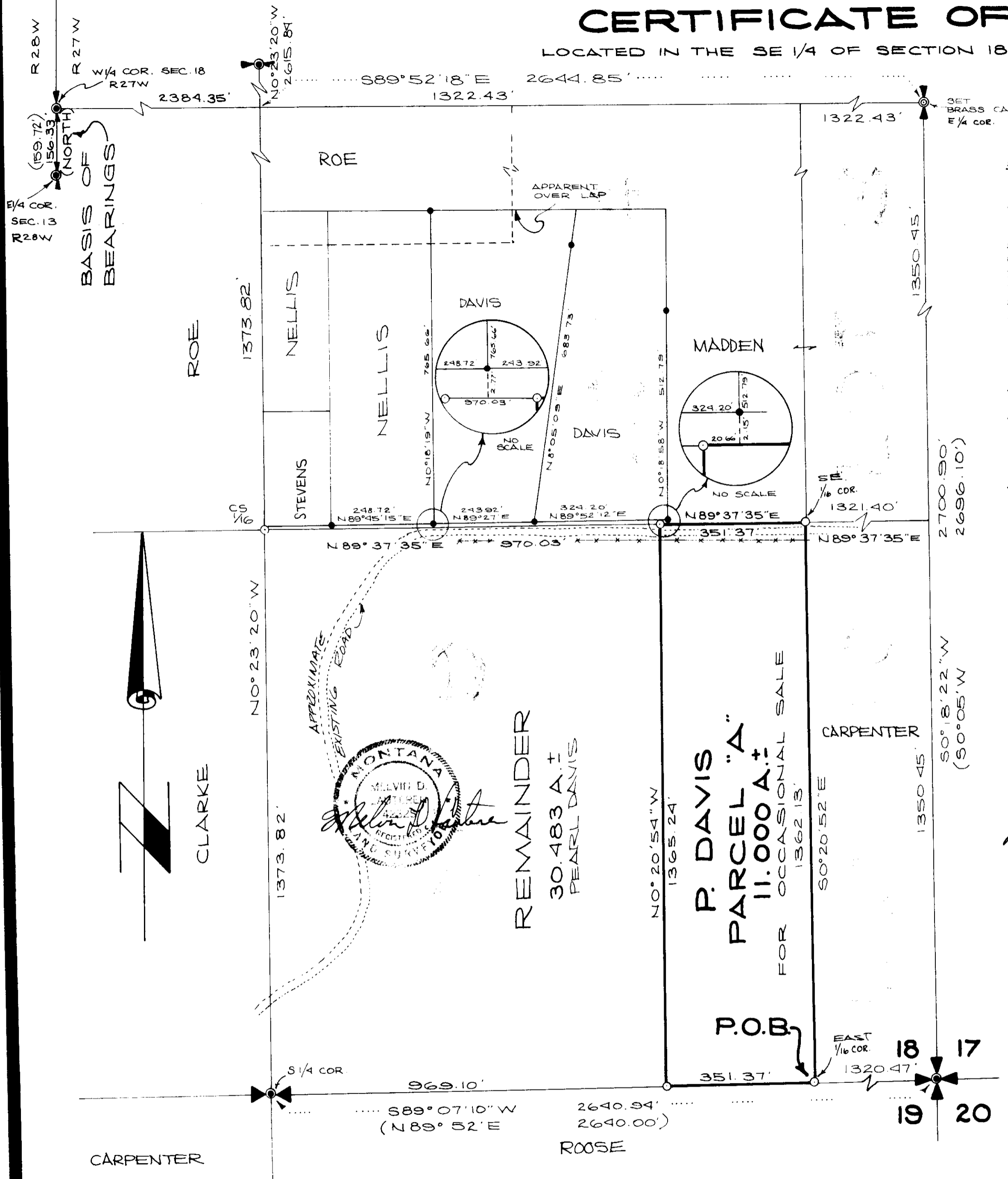


LINCOLN COUNTY, MONTANA CERTIFICATE OF SURVEY

DESCRIPTION PARCEL "A"

A parcel of land located in Government Lot 9 in the SE 1/4 of Section 18, T36N, R27W, P.M.M. near Bureka, Montana.

Beginning at a 5/8 inch rebar tagged MDL 4232-5 being the E 1/16 corner of Sections 18 and 19, T36N, R27W, P.M.M., said point bears S89°07'10"W 1320.47 feet from the Southeast Corner of said Section 18; thence, along the Section line S89°07'10"W 351.37 feet to a 5/8 inch rebar tagged MDL 4232-5; thence, leaving said line N0°20'54"W 1365.24 feet to a 5/8 inch rebar tagged MDL 4232-5 located on the north boundary of Government Lot 9; thence, N89°37'35"W 351.37 feet to a 5/8 inch rebar tagged MDL 4232-5; thence, S0°20'52"E 1362.13 feet along the east boundary of Government Lot 9 to the Point of Beginning.

This parcel contains 11.000 acres more or less.

PURPOSE OF SURVEY: is parcel creation for occasional sale.

BASE OF BEARINGS: is that line on the westerly Boundary of Section 18, T36N, R27W, P.M.M. between the W 1/4 Corner of said Section 18, and the E 1/4 Corner of Section 19, T36N, R27W, P.M.M., reported as (North)

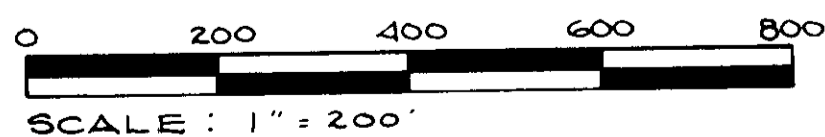
