
Originally Plat No. 1872 and Plat No. 1979 were filed showing County Road rights of way as 25.00 feet on each side of centerline. Subsequently C. of S. No. 155 was filed to amend the County Road rights of way to 30.00 feet on each side of centerline, also amending the County Roads to agree with a Road Retracement survey. Adjoining owners requested the rights of way be narrowed back to 25.00 feet on each side of centerline per the original plats, wo Certificate of Survey No. 1554 was filed for that purpose. This explains the slight differences in bearings, distances, acreages, etc. on the Plate and Certificates of Survey.

Beginning at the intersection of the east-west centerline of Section 18 Twp. 30 N., R. 33 W., M.P.M. with the southeasterly right of way line of the Keeler Creek Road at a distance of 25.00 feet measured at right angles from the centerline thereof, which point of beginning lies N 89°36'40" E 145.84 feet from the Center 1/4 Corner of said Section 18; thence, along said southeasterly right of way line, N 26°56'00" E 439.29 feet; thence, leaving said southeasterly right of way line, N 86°32'45" E 557.99 feet to a point on the east line of Plat No. 1872 and Certificate of Survey No.s 155 and 155A of Lincoln County, Montana records; thence, along said east line, S 0°00'34" W 420.13 feet to a point on the east-west centerline of said Section 18; thence, along said east-west centerline, S 69 36 40" W 755.90 feet to the point of beginning.
