# CERTIFICATE OF SURVEY

IN THE SE 1/4 SW 1/4 OF SECTION 14
TWP. 30 N., R. 31 W., M.P.M.

JUNE, 1979

### DESCRIPTION

An irregular tract of land near Libby in Lincoln County, Montana, lying wholly within the SE SW2 of Section 14 Twp. 30 N., R. 31 W., M.P.M., containing 0.289 acre, more or less, and more particularly described as follows:

Beginning at the southwest corner of the SE<sup>1</sup>/<sub>4</sub> SW<sup>1</sup>/<sub>4</sub> of Section 14 Twp. 30 N., R. 31 W., M.P.M.; thence, along the south line of said Section 14, N 89 43 07" E 133.77 feet to a point on the southwesterly right of way line of U.S. Highway No. 2; thence, northwesterly, on the arc of a curve to the right having a radius of 2915.00 feet, which radius bears N 52 57 43" E, turning through an angle of 4 37 16" a distance of 235.11 feet to a point on the west line of the SE<sup>1</sup>/<sub>2</sub> SW<sup>1</sup>/<sub>4</sub> of said Section 14 where the radius bears N 57 34 59" E; thence, leaving said southwesterly right of way line, along said west line, S 0 02 18" E 193.83 feet to the point of beginning.

# PURPOSE FOR SURVEY

The purpose of this survey is to locate the boundaries of an existing tract of land, being that part of the Soc SW2 of Section 14 Twp. 30 N., R. 31 W., M.F.M. lying southwest of U.S. Highway No. 2 right of way.

### BASIS FOR BEARINGS

Bearings were based on the bearing of the west half of the South line of Section 14 Twp. 30 N., R. 31 W., M.P.M. reported to bear N 89°43'07" E on C. of S. No. 222 of Lincoln County, Montana records.
