DESCRIPTION

Commencing at the NE1/4 corner of Sec. 17, T. 26 N., R. 28 W., P.M.M., Lincoln County, Montana which is a found B.L.M. brass cap; thence S 89° 33' 13" E along the North boundary of the NE1/4 of said Sec. 17 a distance of 883.18 feet to a set iron pin which is the true point of beginning of the tract of land herein described; thence S 89° 33' 13" E along said North boundary a distance of 60.83 feet to a set iron pin which is the P.C. of a 3220.60 foot radius curve concave Northeastly (radial bearing N 80° 57' 23" E); thence Southeastly along said curve through a central angle of 06° 27' 21" an arc length of 362.88 feet to a set iron pin which is the point of reverse curvature of a 3906.10 foot radius curve concave Southwestly (radial bearing S 74° 30' 02" W); thence Southeastly along said curve through a central angle of 03° 36' 30" an arc length of 246.00 feet to a set iron pin; thence S 11° 53' 28" E 338.87 feet to a set iron pin which is the P.C. of a 10030.00 foot radius curve concave Southwestly; thence Southeastly along said curve through a central angle of 03° 19' 21" an arc length of 581.63 feet to a set iron pin; thence S 08° 34' 07" E 363.75 feet to a set iron pin which is the P.C. of a 870.00 foot radius curve concave Northeastly; thence Southeastly along said curve through a central angle of 39° 27' 03" an arc length of 599.04 feet to a set iron pin; thence S 48° 01' 10" E 227.01 feet to a set iron pin which is the P.C. of a 530.00 foot radius curve concave Southwestly; thence Southeastly along said curve through a central angle of 17° 42' 34" an arc length of 163.82 feet to a set iron pin on the South boundary of said NE1/4; thence S 89° 51' 00" W along said South boundary a distance of 70.96 feet to a set iron pin which is a point on a 470.00 foot radius curve concave Southwestly (radial bearing S 55° 20' 23" W); thence Northwestly along said curve through a central angle of 13° 21' 33" an arc length of 109.59 feet to a set iron pin; thence N 48° 01' 10" W a distance of 227.01 feet to a set iron pin which is the P.C. of a 930.00 foot radius curve concave Northeastly; thence Northwestly along said curve through a central angle of 39° 27' 03" an arc length of 640.35 feet to a set iron pin; thence N 08° 34' 07" W a distance of 363.75 feet to a set iron pin which is the P.C. of a 9970.00 foot radius curve concave Southwestly; thence Northwestly along said curve through a central angle of 03° 19' 21" an arc length of 578.15 feet to a set iron pin; thence N 11° 53' 28" W a distance of 338.87 feet to a set iron pin which is the P.C. of a 3846.10 foot radius curve concave Southwestly; thence Northwestly along said curve through a central angle of 03° 36' 30" an arc length of 242.22 feet to a set iron pin which is the point of reverse curvature of a 3280.60 foot radius curve concave Northeastly (radial bearing N 74° 30' 02" E); thence Northwestly along said curve through a central angle of 06° 27' 21" an arc length of 369.64 feet to a set iron pin; thence N 09° 02' 37" W a distance of 10.03 feet to the place of beginning and containing 3.969 acres of land more or less. 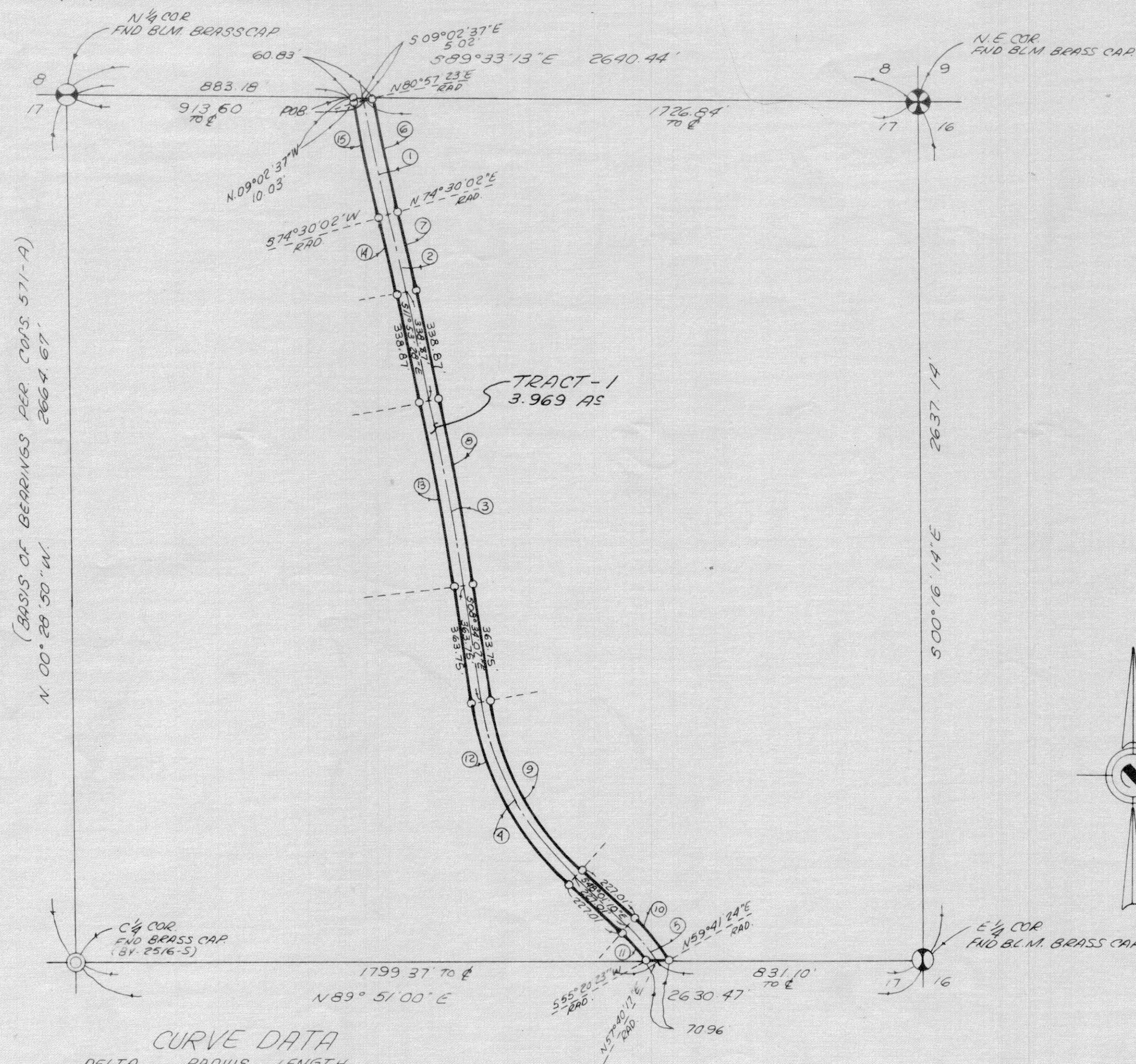

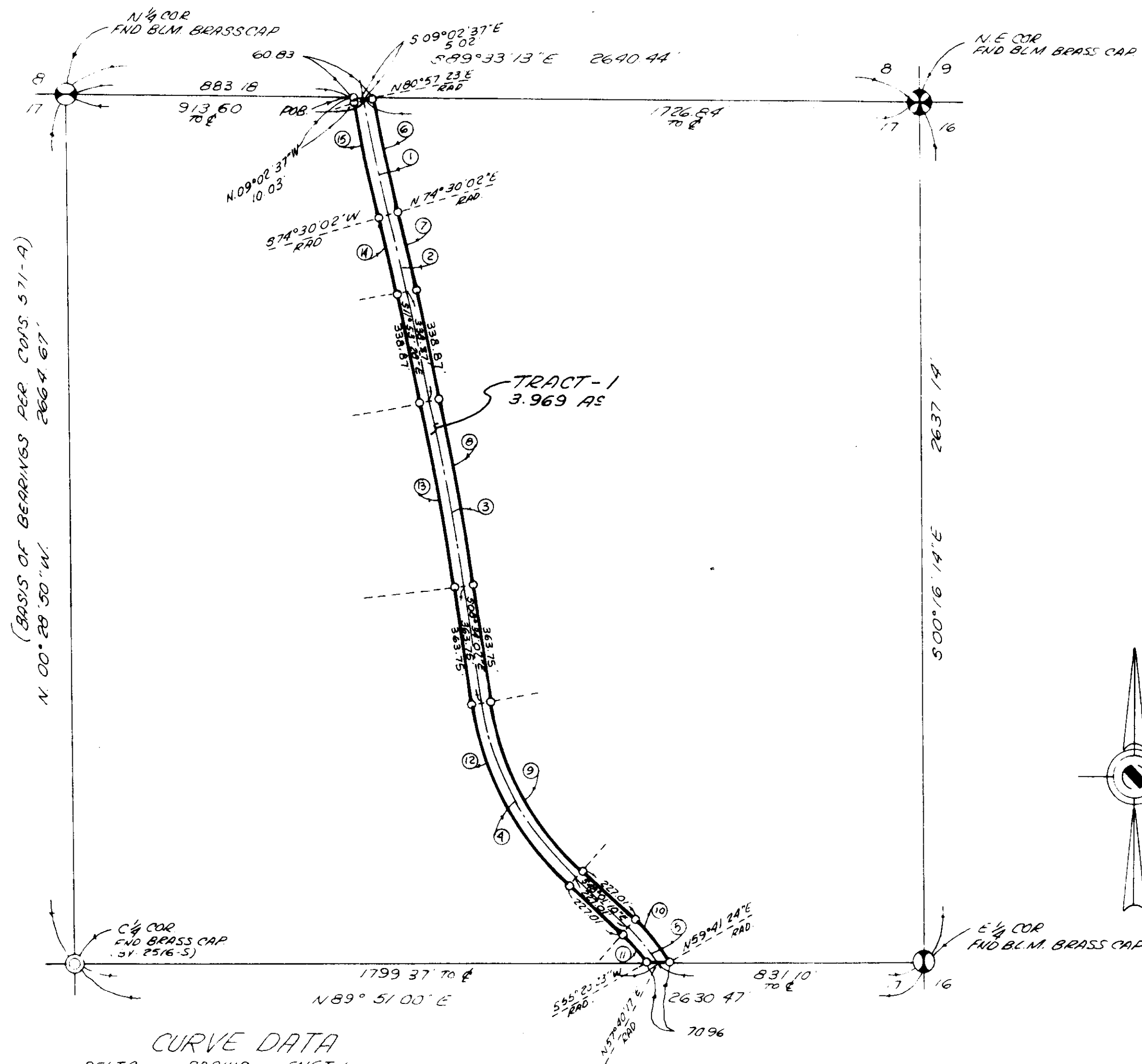
