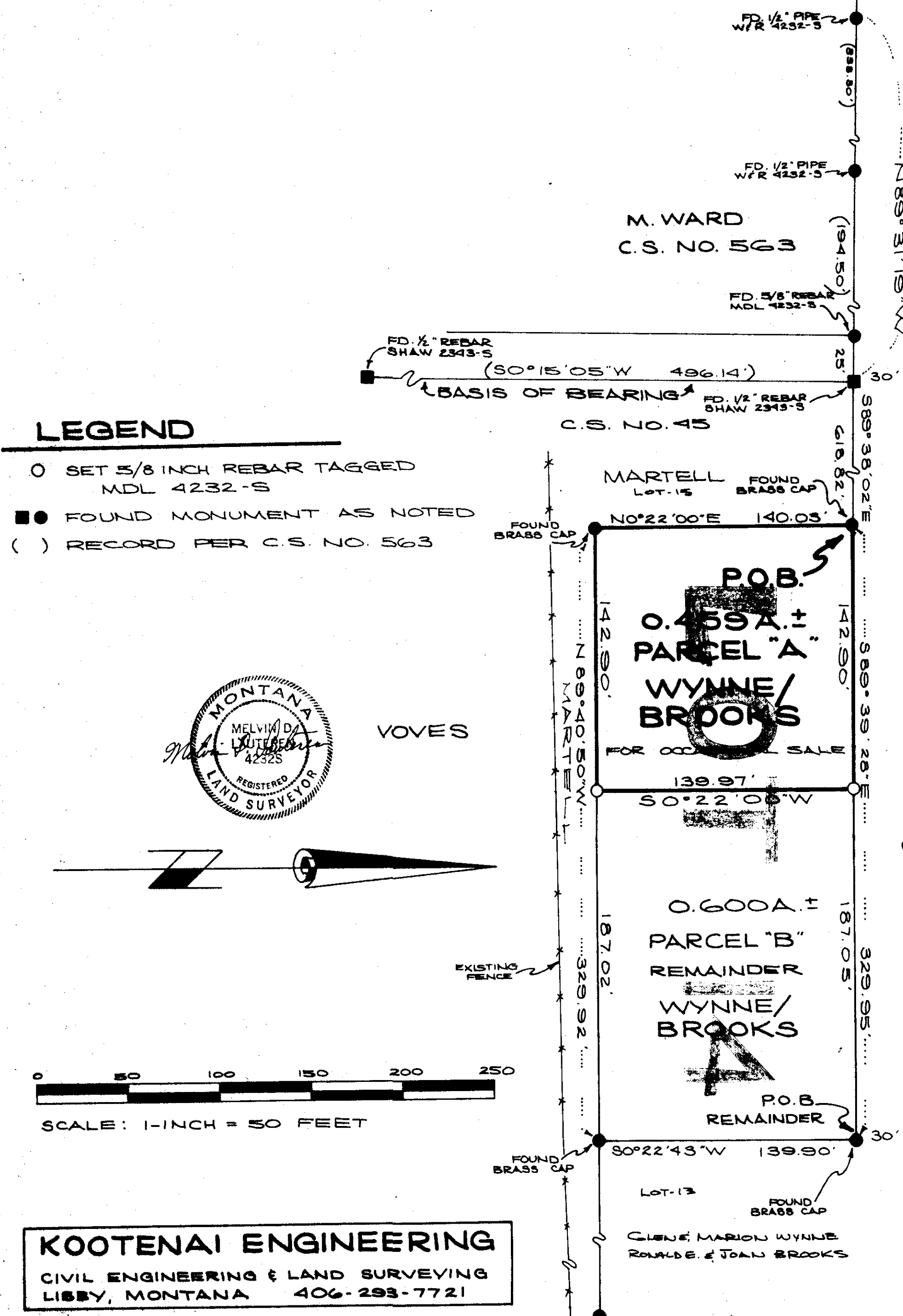

DESCRIPTION PARCEL "A"

A parcel of land located in the N 1/2 of the N 1/2 of the SE 1/4 of the SW 1/4 of Section 24, T30N, R31W, P.M.M. in Lincoln County near Libby, Montana, containing 0.459 acres more or less.

Beginning at a found Brass Cap located on the Southerly right of way line of a 60.00 foot wide County Road right of way being the Northwest corner of Lot 14, Wards Tracts; thence, along said right of way line S 89°39'28"E 142.90 feet to a set 5/8 inch rebar tagged MDL 4232-S; thence, leaving said right of way line S 0°22'00"W 139.97 feet to a set 5/8 inch rebar tagged MDL 4232-S; thence, N 89°40'50"W 142.90 feet to a found Brass Cap; thence, N 0°22'00"E 140.03 feet to the Point of Beginning.
