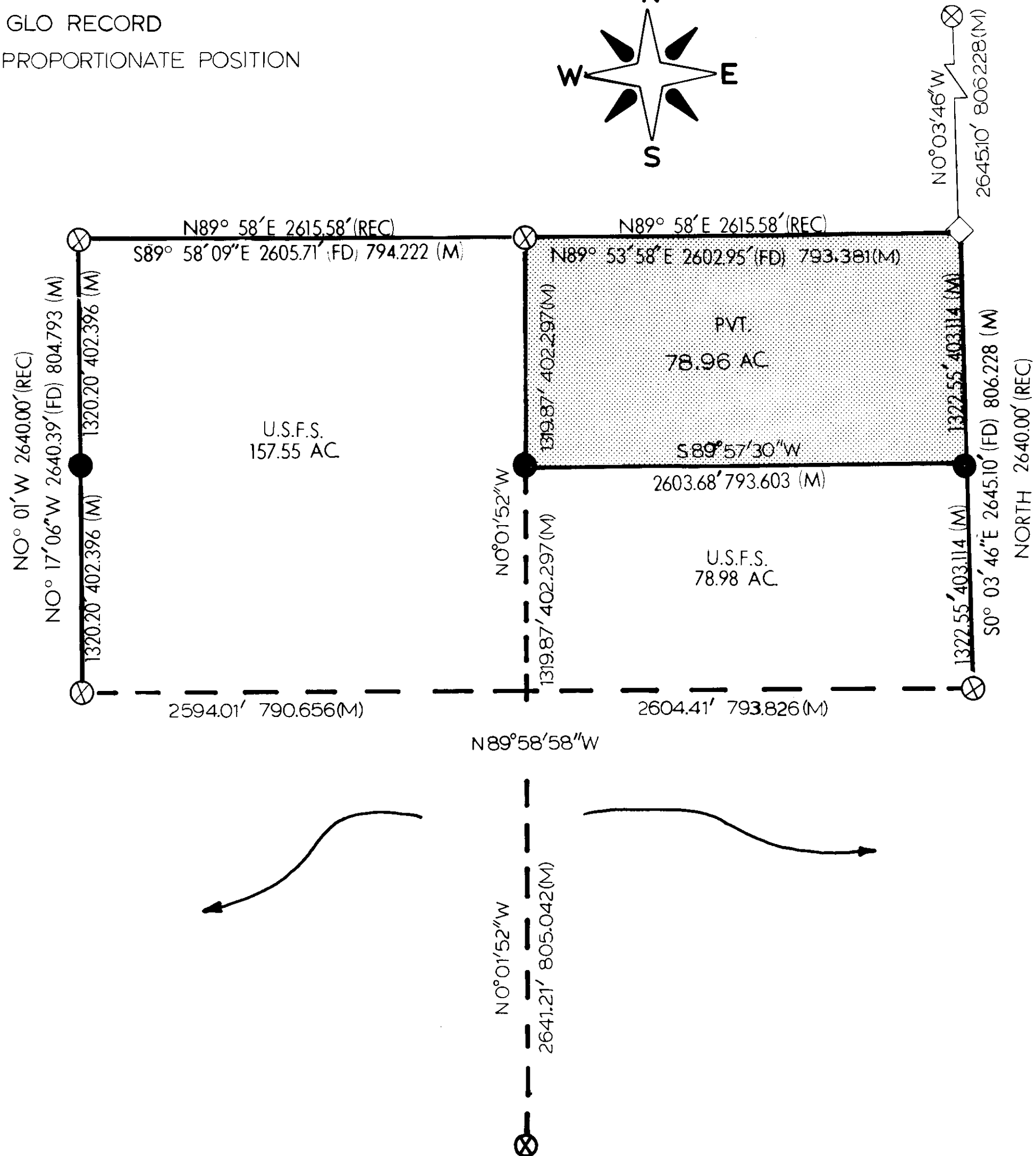
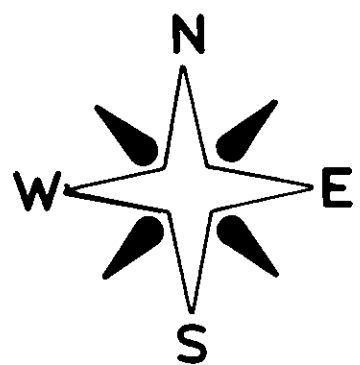
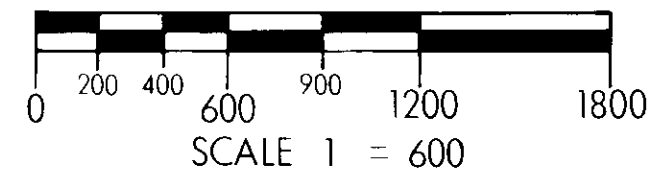

NOTES AND LEGAL DESCRIPTION:

THIS PLAT REPRESENTS A RETRACEMENT AND SUBDIVISION OF SECTION 24, TOWNSHIP 34 NORTH, RANGE 26 WEST, PRINCIPAL MERIDIAN MONTANA. REFERENCE SHOULD BE MADE TO THE NOTES AND PLAT DATED AUGUST 1894.

PURPOSE OF THIS SURVEY IS TO DETERMINE THE BOUNDARY LINE BETWEEN PRIVATE AND U.S. FOREST SERVICE LANDS: U.S. FOREST SERVICE LANDS BEING LEGALLY DESCRIBED AS: ALL THAT PORTION OF SAID SECTION 24, EXCEPT THE N 1/2 OF THE NE 1/4.

THIS SURVEY WAS COMPLETED UTILIZING A COMBINATION OF PHOTOGRAMMETRIC AND CONVENTIONAL METHODS IN ATTAINING AN ACCURACY EXCEEDING THIRD ORDER, CLASS II STANDARDS. THE FIELD NOTES, PHOTOGRAPHY, AND COMPUTATIONS ARE FILED WITH U.S.D.A., FOREST SERVICE, KOOTENAI NATIONAL FOREST, SUPERVISOR'S OFFICE, LIBBY, MONTANA.

ALL BEARINGS ARE BASED UPON THE PUBLISHED COORDINATES OF U.S.C. AND G.S. STATIONS, MARSTON AND SUNDAY.

ALL MONUMENTS SET ARE 3 x 30 INCH ALUMINUM PIPES WITH ALUMINUM CAPS. FOR CORNER INFORMATION SEE THE RECORDATION FILE IN LINCOLN COUNTY COURT HOUSE, LIBBY, MONTANA.
