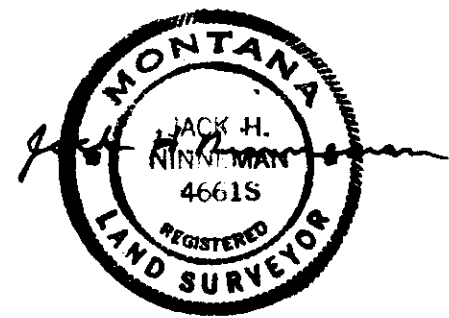
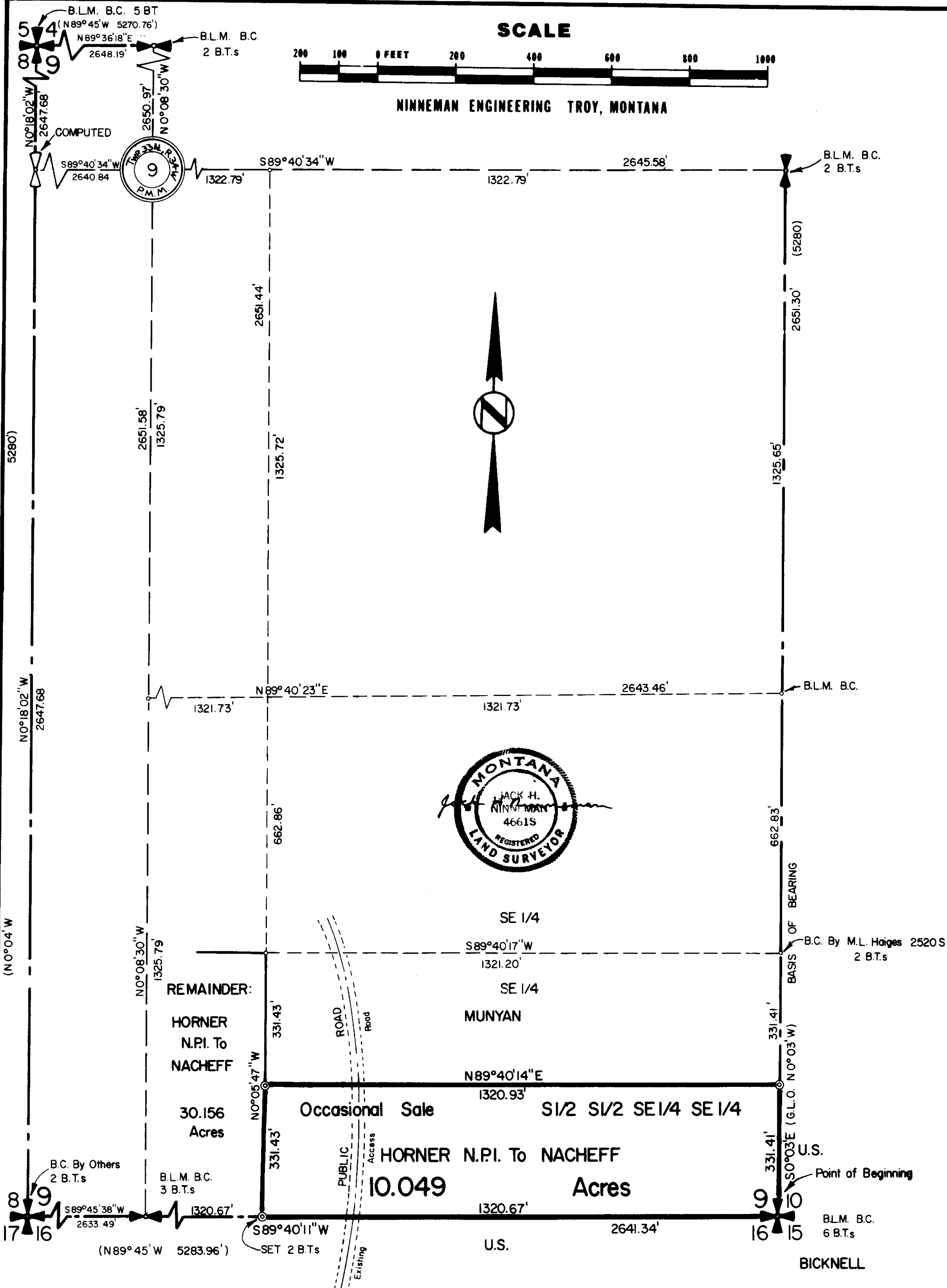

DESCRIPTION OCCASIONAL SALE

Beginning at the Southeast Corner of Section 9 Twp. 33 N., R. 34 W., P.M.M.; thence, along the south line of said Section 9, S 89°40'11" W 1320.67 feet to the southeast corner of the SE 1/4 SE 1/4 of said Section 9; thence, along the west line of said SE 1/4 SE 1/4, N 0°05'47" W 331.43 feet to the northwest corner of the 1/2 1/2 SE 1/4 SE 1/4 of said Section 9; thence, along the north line of said 1/2 1/2 SE 1/4 SE 1/4, N 89°40'14" E 1320.93 feet to the northeast corner thereof on the east line of said Section 9; thence, along the east line of said Section 9, S 0°03' E 331.41 feet to the point of beginning.
SUBJECT to an Existing Access Road, being a Public Road by right of use, crossing through the aforesaid 10.049 acre tract of land generally as shown hereon.
