THAT PORTION OF THE SOUTHEAST 1/4 OF THE SOUTHEAST 1/4 OF THE SOUTHEAST 1/4, SECTION 11, TOWNSHIP 36 NORTH, RANGE 27 WEST, P.M.M., LINCOLN COUNTY, MONTANA DESCRIBED AS FOLLOWS:
COMMENCING AT THE SOUTHEAST CORNER OF THE NORTH 1/2 OF THE SOUTHEAST 1/4 OF THE SOUTHEAST 1/4 OF THE SOUTHEAST 1/4, SECTION 11; THENCE ALONG THE SOUTH LINE OF THE NORTH 1/2 OF THE SOUTHEAST 1/4 OF THE SOUTHEAST 1/4 OF THE SOUTHEAST 1/4 NORTH 89°48'32" WEST 30.00 FEET TO THE POINT OF BEGINNING, WHICH POINT IS ON THE WEST LINE OF A COUNTY ROAD; THENCE CONTINUING ALONG THE SOUTH LINE NORTH 89°48'32" WEST 624.85 FEET; THENCE SOUTH 0°41'13" WEST 69.71 FEET; THENCE SOUTH 89°48'32" EAST 624.81 FEET TO THE WEST LINE OF THE COUNTY ROAD; THENCE ALONG THE WEST LINE OF THE ROAD NORTH 0°43'25" EAST 69.71 FEET TO THE POINT OF BEGINNING, CONTAINING 1.000 ACRE OF LAND, ALL AS SHOWN HEREON.

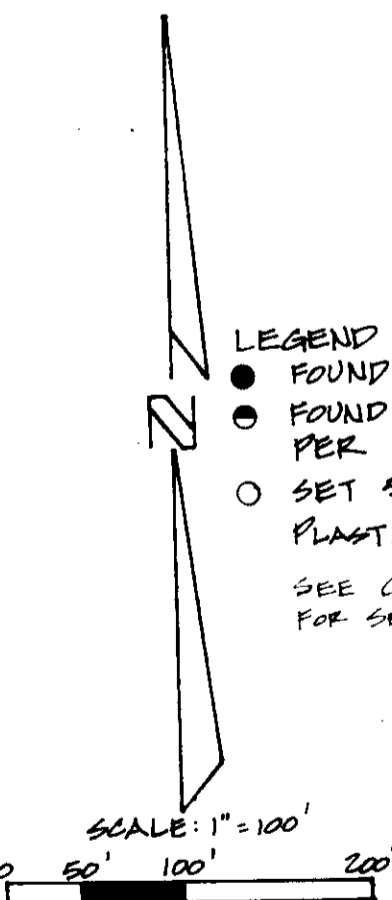
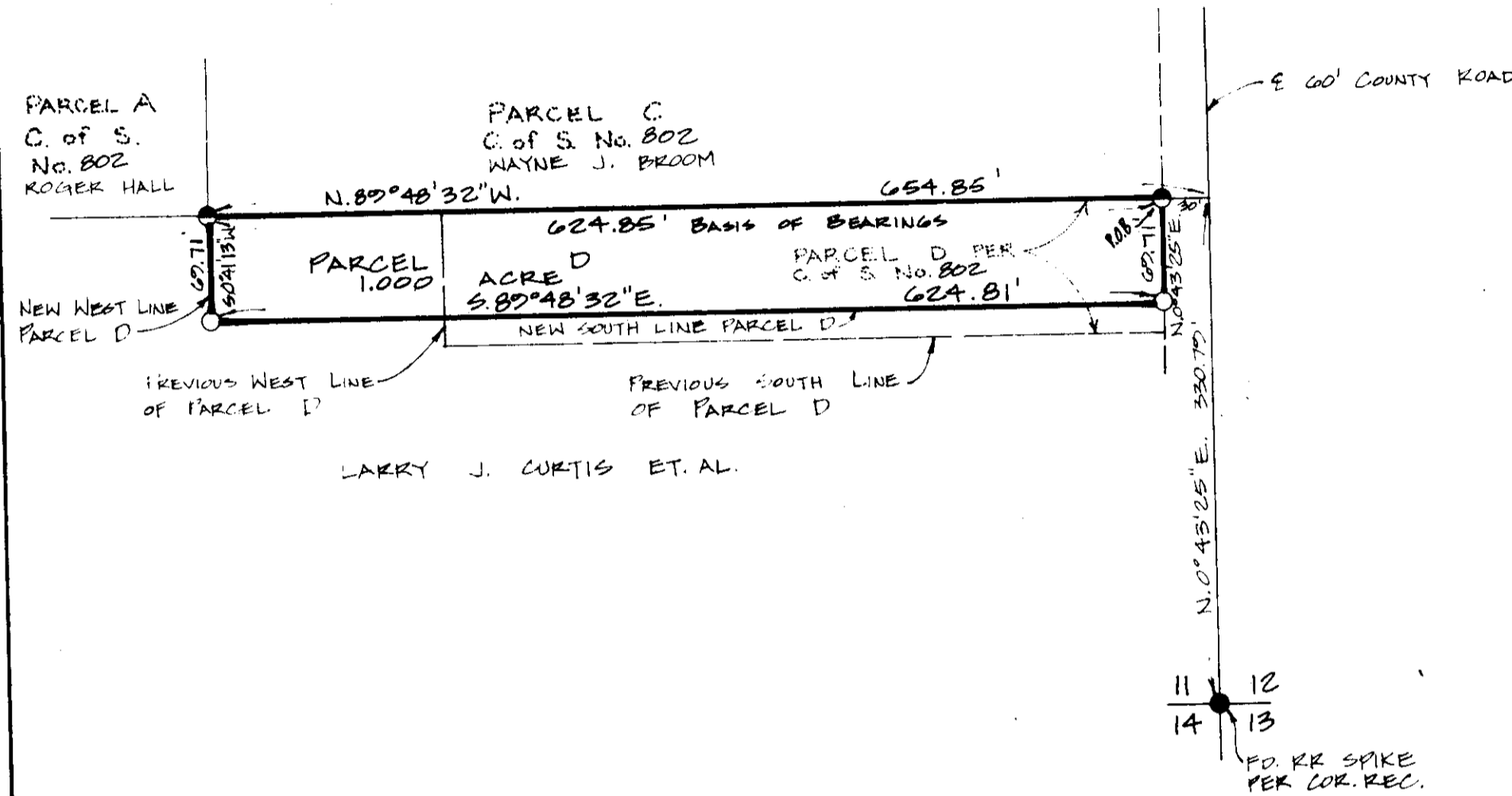
