

No. 131; thence, along said northwesterly line of said C. of S. No. 131, northeasterly on the arc of a curve to the left having a radius of 730.00 feet, which radius bears N 35019 54" W. turning through an angle of 8026'06" a distance of 107.47 feet; thence, N 46014' E 111.97 feet; thence, on the arc of a curve to the right having a radius of 135.22 feet, turning through an angle of 43°37'00" a distance of 102.94 feet to the northeast corner of said C. of 8. Beginning at a southwesterly corner of Certificate of Survey No. 131 of Lincoln County, Montana records in Lot 1 of Section 33 Twp. 31 N., R. 33 W., P.M.M.; thence, from said point of beginning, along the westerly line of said C. of S. No. 131, northerly on the arc of a curve to the right having a radius of 15.00 feet, which radius bears N 0 18' E, turning through an angle of 154 57 50 a distance of 40.57 feet; thence, along the northwesterly line of said C. of S. No. 131, northeasterly on the arc of a curve to the left having a radius of 730.00 feet, which radius bears N 21 44 10" W, turning through an angle of 10 35 44" a distance of 135.00 feet; thence, leaving said northwesterly line, S 0018' W 96.67 feet to a point on the southerly line of said C. of S. No. 131; thence, along the southerly line of said C. of S. No. 131. N 89 42 W 110.00 feet to the point of beginning.
