CERTIFICATE OF SURVEY

Part of the S 1/2 of Section 1 Twp. 31 N., R. 34 W., M.P.M.

JUNE 1980

DESCRIPTION

A tract of land lying between a County Road, known as Kibrennan Road and Kootenai River, being a part of Government Lots 8 and 11 of Section 1 Twp. 31 N., R. 34 W., P.M.M., containing 16.977 acres, more or less, and more particularly described as follows:

Beginning at a point on the westerly right of way line of Kibrennan Road, which point is 615.02 feet north and 3215.14 feet east from the southwest corner of Section 1 Twp. 31 N., R. 34 W., P.M.M., thence, along said right of way line, northwesterly, on the arc of a curve to the right having a radius of 1195.0 feet which radius bears S 62°09'46"W, turning through an angle of 120°07'41", a distance of 252.95 feet; thence N 19°42'33"W 384.28 feet; thence, on the arc of a curve to the right, having a radius of 1780.0 feet, turning through an angle of 7°01'25", a distance of 218.20 feet; thence, N 8°41'00"W 389.24 feet; thence, on the arc of a curve to the left having a radius of 470.0 feet, turning through an angle of 21°12'19", a distance of 198.56 feet; thence, N 32°33'27"W 62.49 feet; thence, on the arc of a curve to the right having a radius of 1030.0 feet, turning through an angle of 7°36'10", a distance of 136.67 feet; thence, N 25°17'17"W 52.40 feet; thence, on the arc of a curve to the left having a radius of 370.0 feet, turning through an angle of 33°39'11", a distance of 217.32 feet; thence, N 58°56'28"W 145.75 feet; thence, on the arc of a curve to the right having a radius of 240.0 feet, turning through an angle of 42°51'10", a distance of 179.50 feet; thence, on the arc of a curve to the left having a radius of 872.71 feet, turning through an angle of 6°25'17", a distance of 97.81 feet to a point on the east-west centerline of said Section 1; thence, along said east-west centerline, N 89°40'33"W 193.64 feet to a point on the easterly bank of the Kootenai River, which point is 2122.80 feet S 89°40'33"E from the W 1/4 Corner for said Section 1, (and which point is witnessed by a capped steel rod stamped 4661 S, on said east-west line, at 11.0' east of said easterly bank); thence, along said easterly bank or edge of said River (intending to mean edge of water, thereby leaving no ungranted land between edge of water and top of bank as surveyed, indicated, and described herein) upstream, the following twelve courses: S 12°11'E 132.5 feet; thence S 30°E 105.0 feet; thence S 46°E 125.0 feet; thence S 58°E 95.0 feet; thence S 22°E 125.0 feet; thence S 33°W 70.0 feet; thence S 80°45'W 84.0 feet; thence S 21°30'W 312.0 feet; thence S 25°30'E 188.0 feet; thence S 40°30'E 638.0 feet; thence S 52°E 435.0 feet; thence S 36°19'E 315.7 feet to the point of beginning.

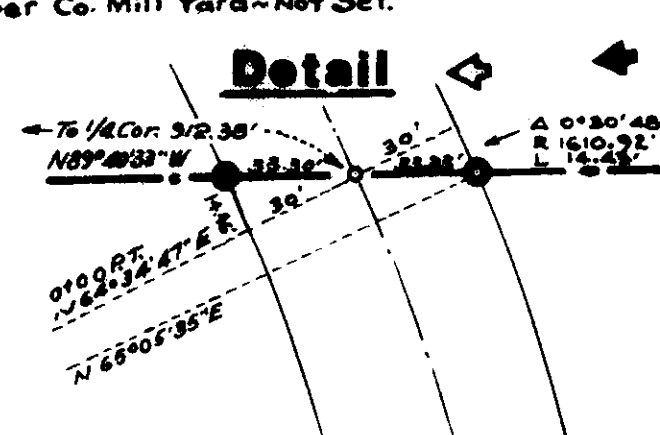
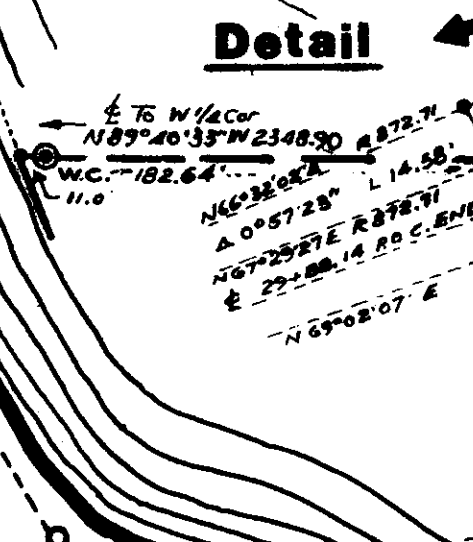
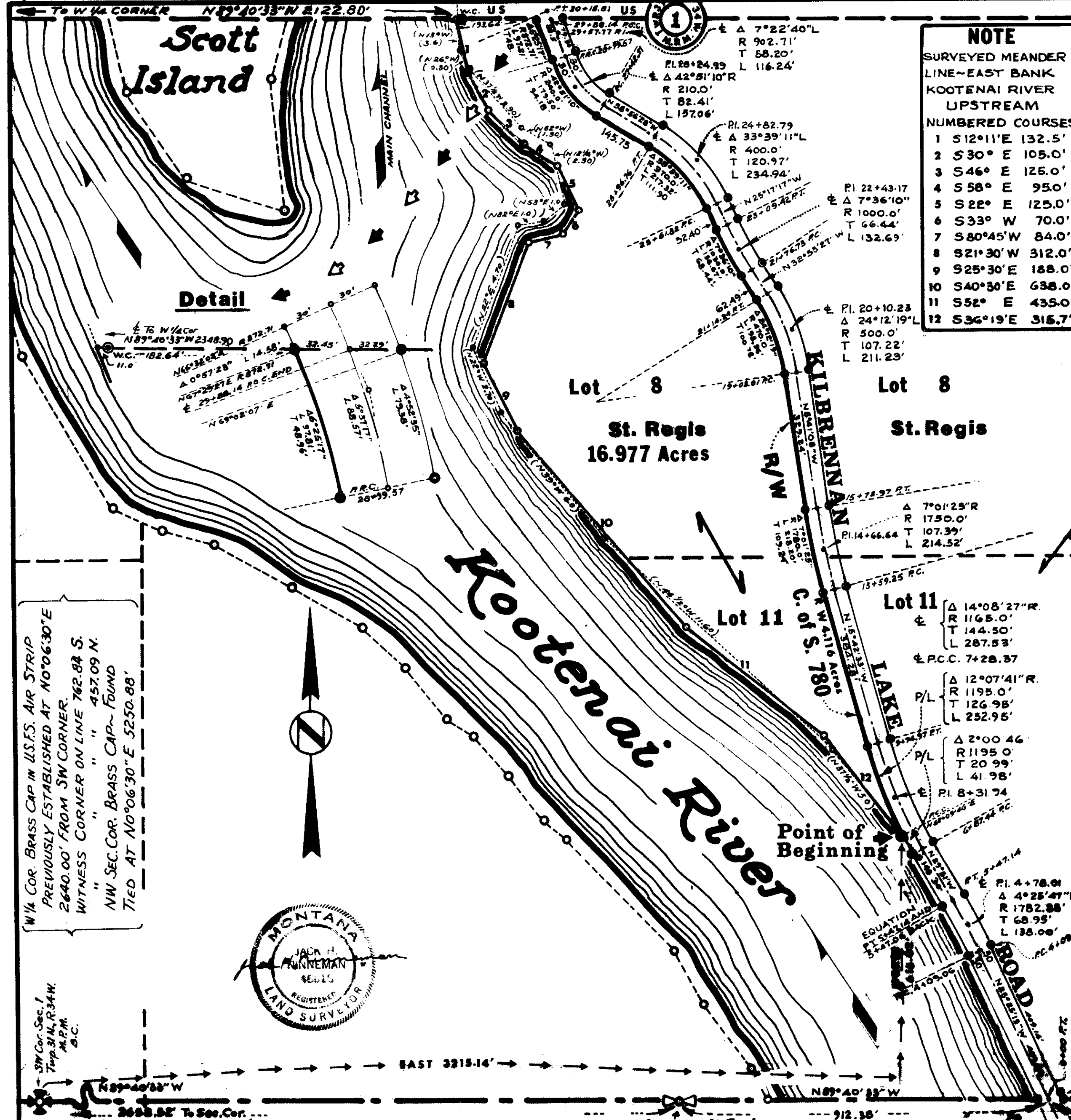
