

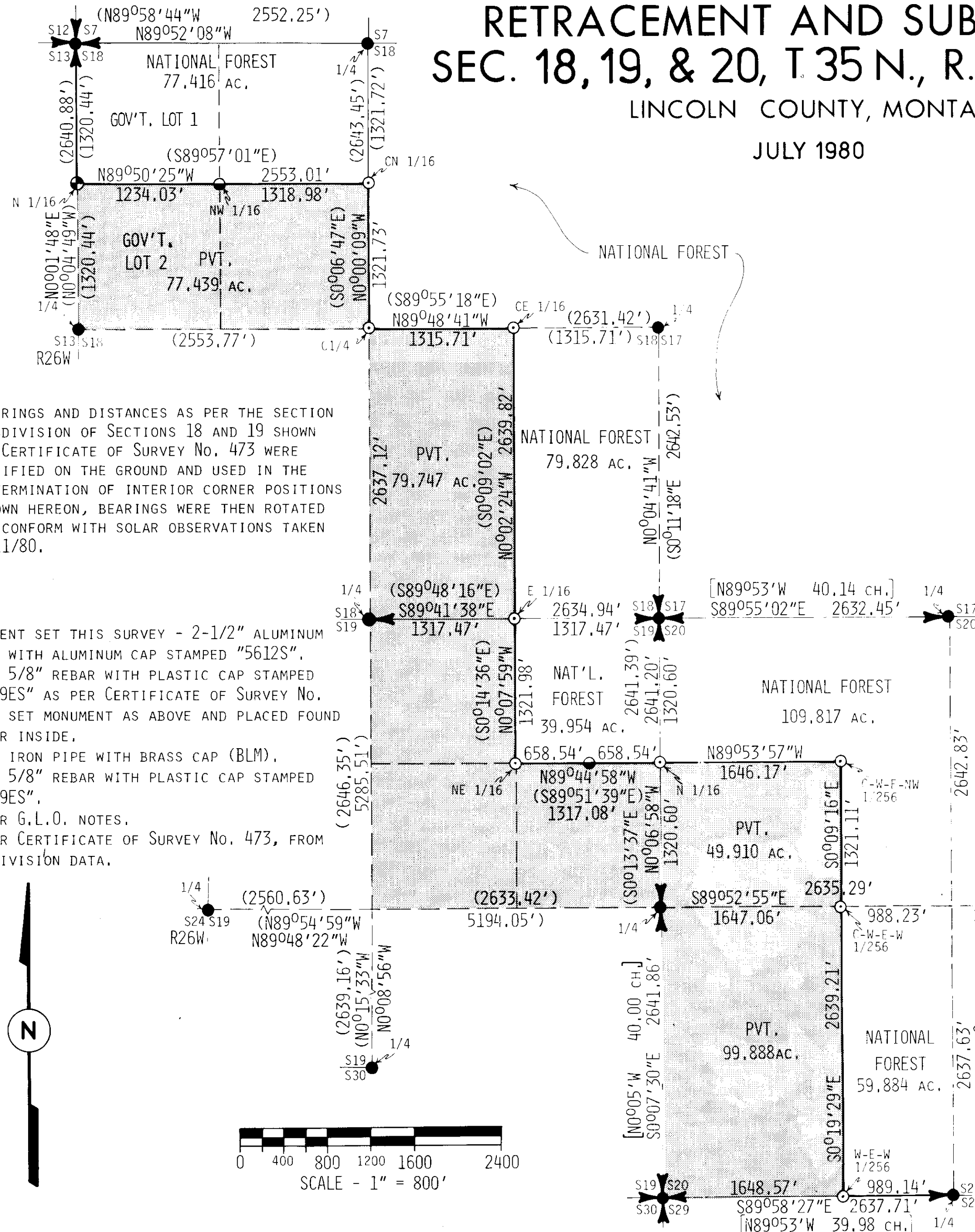

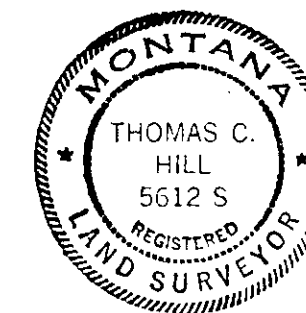

EXCEPT THE SW 1/4 NW 1/4, W 1/2 W 1/2 SE 1/4 NW 1/4, W 1/2 SW 1/4, W 1/2 W 1/2 E 1/2 SW 1/4.
