

Interpretation by William A. Douglas, Lincoln County Attorney:

It is the opinion of the undersigned that the provisions of Section 22. 6. 3001(c), which state as follows:

"... The surveyor shall clearly identify on the face of the plat or certificate of survey all monuments used in the survey, and the descriptions shall be sufficient to identify the monuments without reference to another record of survey."

merely dictate that only those existing monuments which were utilized, or should necessarily have been utilized, by the land surveyor in his conduct of the survey need be shown and described in the Certificate of Survey. The language contained in Section 22. 6. 3002 (4) (g) which states:

"(4) the certificate of survey shall show or contain on its face or on separate sheets referenced on its face the following information:

(g) The location of any corners of sections or divisions of sections pertinent to the survey."

has the same effect for I interpret the word "pertinent" to mean a reference to the corners of sections that are actually utilized by the land surveyor in the conduct of his survey in preparation of the Certificate of Survey. If the corners of the sections, or divisions of sections, have been monumented prior to the conduct of the instant survey, then such monuments are the same monuments to which reference was made under application of Section 22.6.3001.


