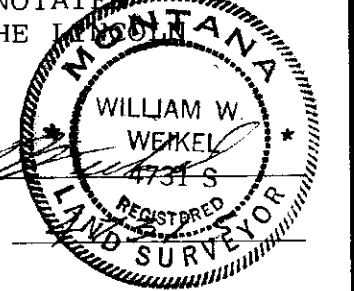
THIS PLAT REPRESENTS A RETRACEMENT OF SECTION 6, T. 27 N., R. 28 W., PRINCIPAL MERIDIAN, MONTANA. REFERENCE SHOULD BE MADE TO THE NOTES AND PLATS DATED: AUGUST, 1900; SEPTEMBER, 1902; AND NOTES DATED 1968 AND 1969.

PURPOSE OF THIS SURVEY IS TO DETERMINE THE BOUNDARY LINE BETWEEN U.S. FOREST SERVICE LANDS AND ALL OTHER OWNERSHIPS; U.S. FOREST SERVICE LANDS BEING LEGALLY DESCRIBED AS: SE 1/4, E 1/2 SW 1/4, LOT 1, LOT 2, LOT 5, LOT 8, LOT 9, LOT 10, LOT 12, LOT 13, LOT 14, LOT 15, LOT 16, LOT 17, LOT 18, SECTION 6, T. 27 N., R. 28 W., P.M.M.

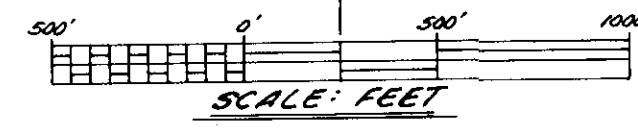
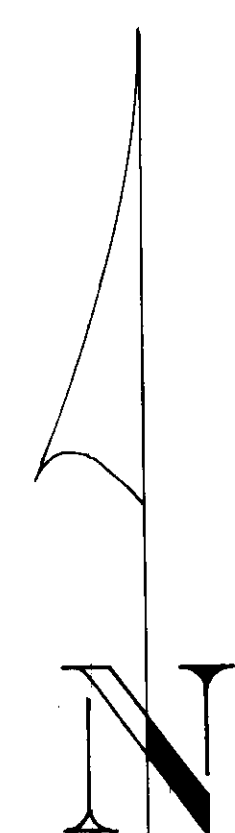

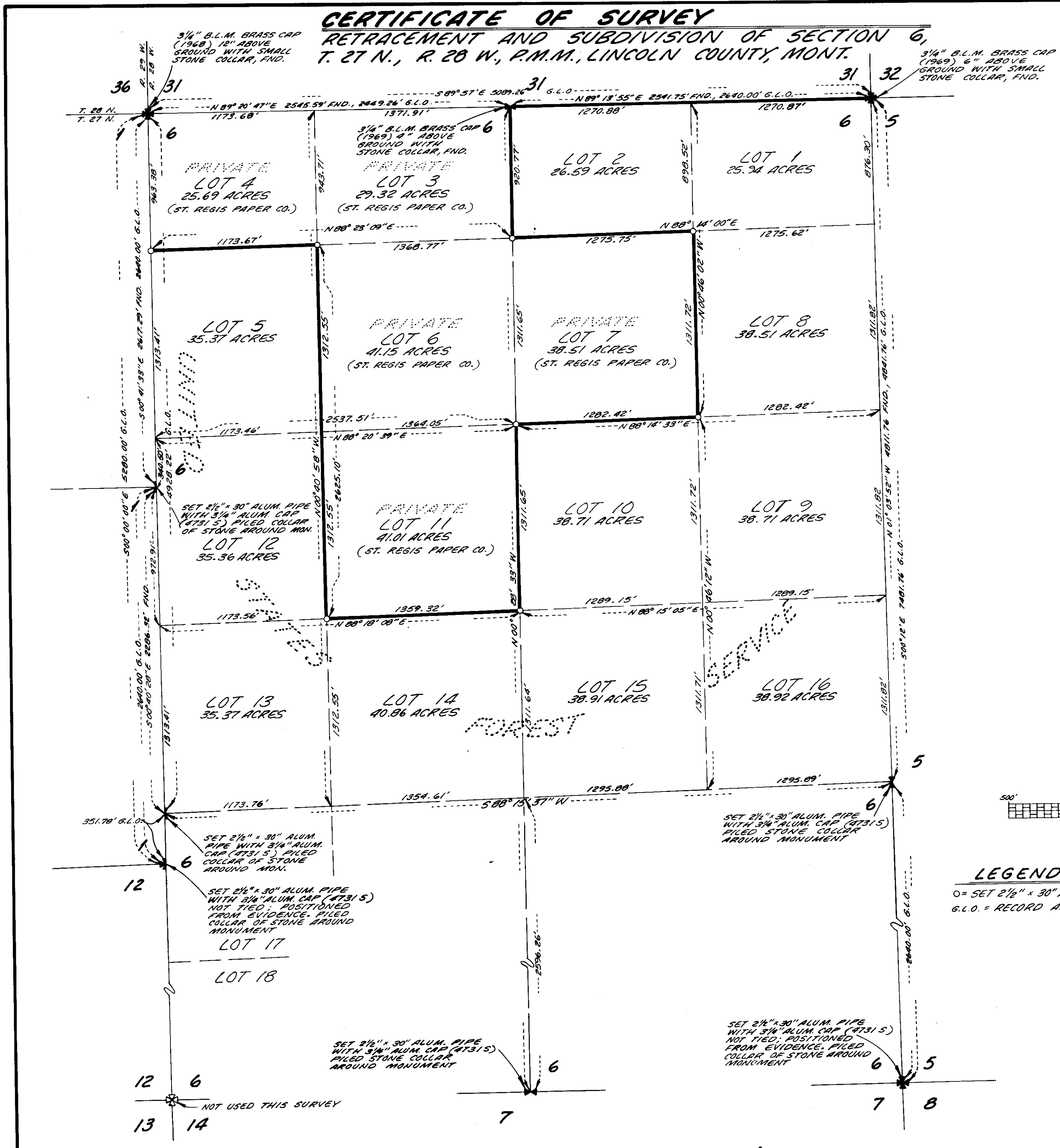
