

PURPOSE OF SURVEY:

THE PURPOSE OF THIS SURVEY IS TO RETRACE AND MARK THE EXTERIOR BOUNDARIES OF AN EXISTING PARCEL OF RECORD, DISTINGUISHING BETWEEN NATIONAL FOREST LANDS AND PRIVATE LANDS AND NO DIVISION OF LAND IS HEREBY CREATED.

All bearings are based upon the G.L.O. record bearing of the S1/2 of the west line of Section 12, being N0 $^{\circ}01'W$.

THIS SURVEY WAS COMPLETED BY UTILIZING CONVENTIONAL TRAVERSE METHODS.
