A PORTION OF H.E.S. NO. 825 LYING NEAR THE CENTER OF SECTION 18, T.30N., R.28W., P.M., M., NEAR LIBBY MONTANA.

DESCRIPTION

A parcel of land near the center of Section 18, T. 30 N., R. 28 W., P.M.M. being a portion of H.E.S. No. 825, near Libby in Lincoln County, Montana.

Beginning at Corner No. 12 of H.E.S. No. 825 being a found stone; thence, N51°28'W 90.00 feet along the Northeasterly boundary of Tract "B", to a 5/8 inch rebar capped: MDL 4232 S; thence, leaving said Northeasterly boundary S35°21'46"W 433.41 feet to a 5/8 inch rebar capped: MDL 4232 S; thence, S41°50'30"E 948.00 feet to a 5/8 inch rebar capped: MDL 4232 S; thence, N48°53'00"E 391.89 feet to a 5/8 inch rebar capped: MDL 4232 S, located on the Northeasterly boundary of said Tract "B" and from which Corner No. 13 bears S39°06'31"E 430.65 feet; thence, along said Northeasterly boundary N39°06'31"W 961.31 feet to the point of beginning. This parcel contains 9.5315 acres, more or less.

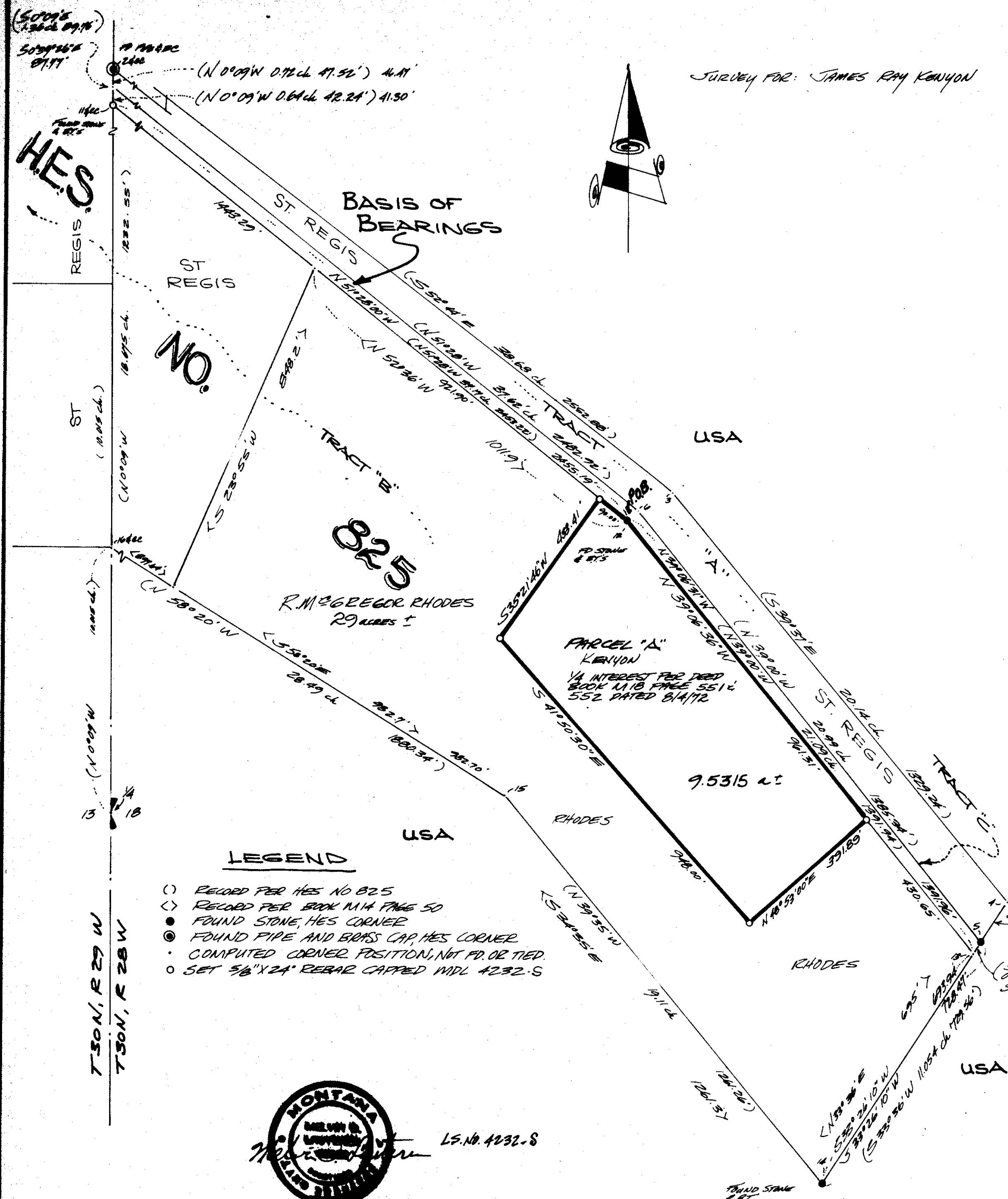
