# CERTIFICATE OF SURVEY

IN THE SE 1/4 SW 1/4 OF SECTION 20
TWP. 31 N., R. 31 W., M.P.M.

### DESCRIPTIO

An irregular tract of land near Libby in Lincoln County, Montana, lying wholly within the SE SW of Section 20 Twp. 31 N., R. 31 W., M.P.M., containing 5.002 acres, more or less, and more particularly described as follows:

Beginning at a Steel Rod Capped J.H.N. 4661 S. at the northeast corner of the SE2 SW2 of Section 20 Twp. 31 N., R. 31 W., M.P.M.; thence, along the north line of the SE2 SW2 of said Section 20, S 89 34'21" W 310.80 feet; thence, leaving said north line, South 695.83 feet to a point in the mid-channel of Pipe Creek; thence, following, generally, said mid-channel of Pipe Creek, upstream, the following five courses: S 56°E 45.93 feet; thence, N 86° E 70.00 feet; thence, N 71° E 116.00 feet; thence, S 74°E 62.00 feet; thence, N 48° E 45.00 feet to a point on the east line of said SE2 SW2, being the north-south centerline of said Section 20; thence, leaving said mid-channel, along said north-south centerline, N 0°00'51" E 668.16 feet to the point of beginning.

INCLUDING an Access and Utilities Easement 30.00 feet in width from the Existing County Road through the remaining 30.008 acres to the SUBJECT 5.002 acre tract of land.

NOTE

Remainder is in excess of 20 acres, therefore not subject to subdivision or sanitary review.
