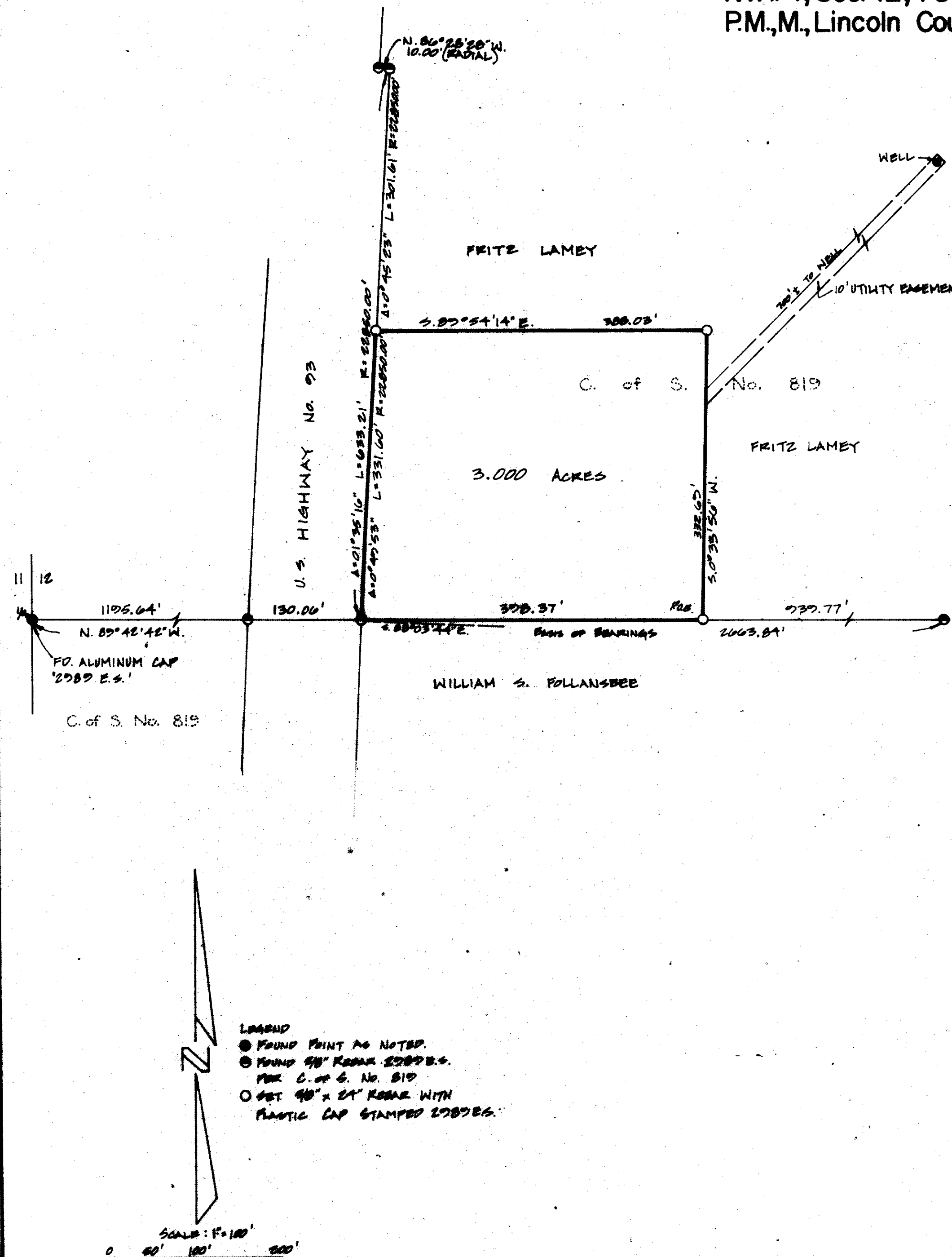

THAT PORTION OF THE SOUTHEAST $\frac{1}{4}$ OF THE NORTHWEST $\frac{1}{4}$, SECTION 12, TOWNSHIP 37 NORTH, RANGE 27 WEST, P.M., M., LINCOLN COUNTY, MONTANA DESCRIBED AS FOLLOWS:
 COMMENCING AT THE SOUTHEAST CORNER OF THE NORTHWEST $\frac{1}{4}$ OF SECTION 12; THENCE ALONG THE SOUTH LINE OF THE NORTHWEST $\frac{1}{4}$ NORTH $89^{\circ}42'42''$ WEST 939.77 FEET TO THE POINT OF BEGINNING; THENCE CONTINUING ALONG THE SOUTH LINE NORTH $89^{\circ}42'42''$ WEST 398.37 FEET TO THE EAST RIGHT OF WAY LINE OF U.S. HIGHWAY No. 93, WHICH POINT IS ON A 22850.00 FOOT RADIUS CURVE CONCAVE SOUTHEASTERLY HAVING A RADIAL BEARING OF SOUTH $88^{\circ}03'44''$ EAST; THENCE NORTHEASTERLY ALONG THE EAST LINE OF THE HIGHWAY THRU A CENTRAL ANGLE OF $0^{\circ}49'53''$ 331.60 FEET; THENCE SOUTH $89^{\circ}54'14''$ EAST 388.03 FEET; THENCE SOUTH $0^{\circ}33'56''$ WEST 332.69 FEET TO THE POINT OF BEGINNING, CONTAINING 3.000 ACRES OF LAND, ALL AS SHOWN HEREON.
