

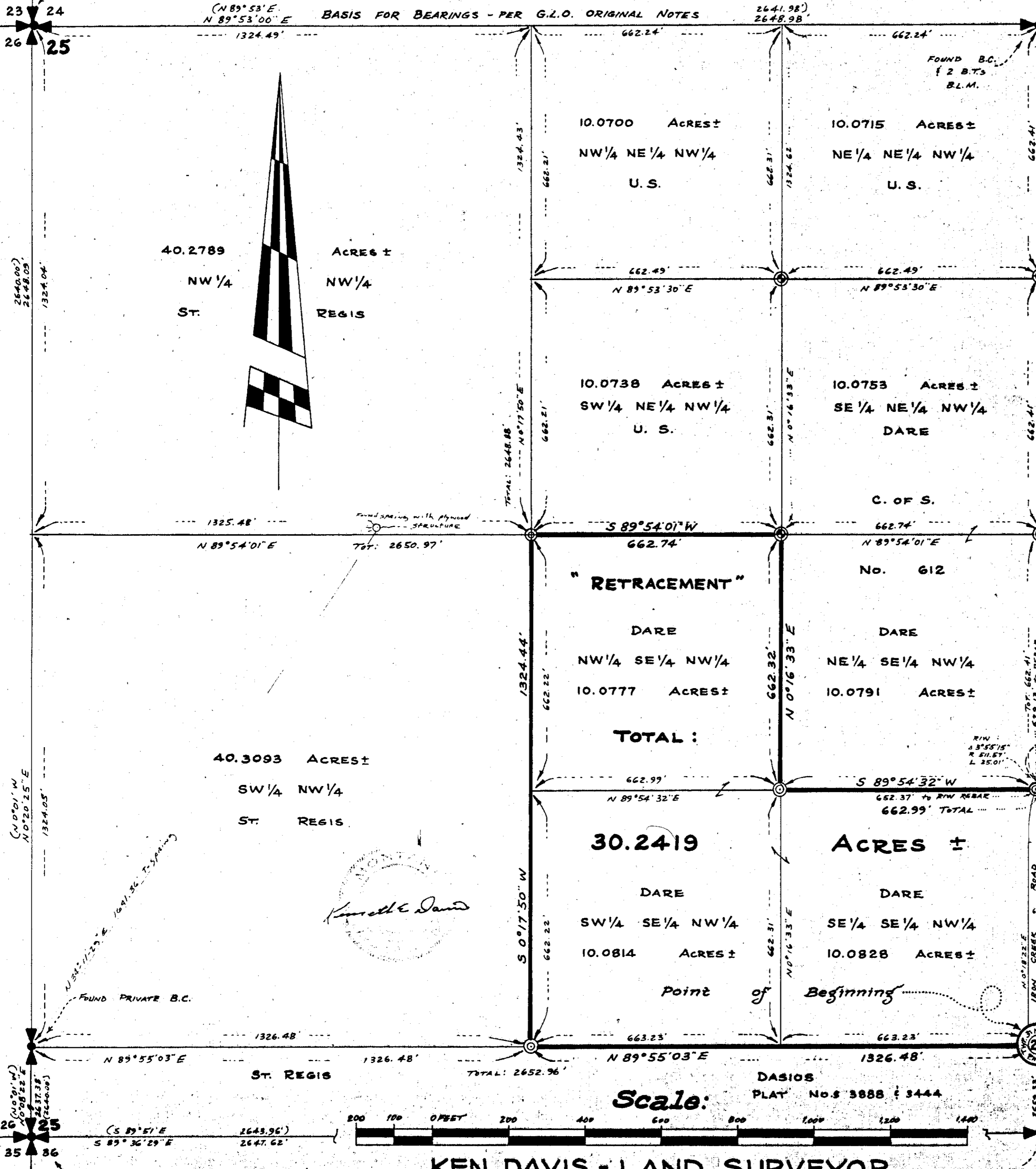

 DESCRIPTION "RETRACEMENT"

A tract of land near Troy in Lincoln County, Montana, being the NW 1/4 SE 1/4 NW 1/4, the SW 1/4 SE 1/4 NW 1/4 and the SE 1/4 SE 1/4 NW 1/4 all of Section 25 Twp. 31 N., R. 34 W., P.M.M., containing a total of 30.2419 acres, more or less, and more particularly described as follows:

Beginning at a 5/8 inch rebar capped: KED 4975 S, in the pavement of the Iron Creek Road (a County Road), marking the Center 1/4 corner of said Section 25; thence, along the north-south centerline of said Section 25, N 0° 15' 15\"/>

NOTE: All Data shown hereon per the breakdown of Section 25 Twp. 31 N., R. 34 W., P.M.M. is per Certificate of Survey No. 612, Lincoln County, Montana records.

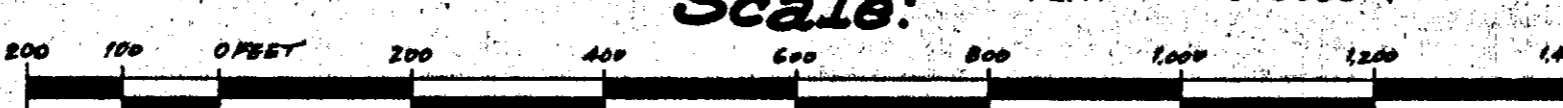
