

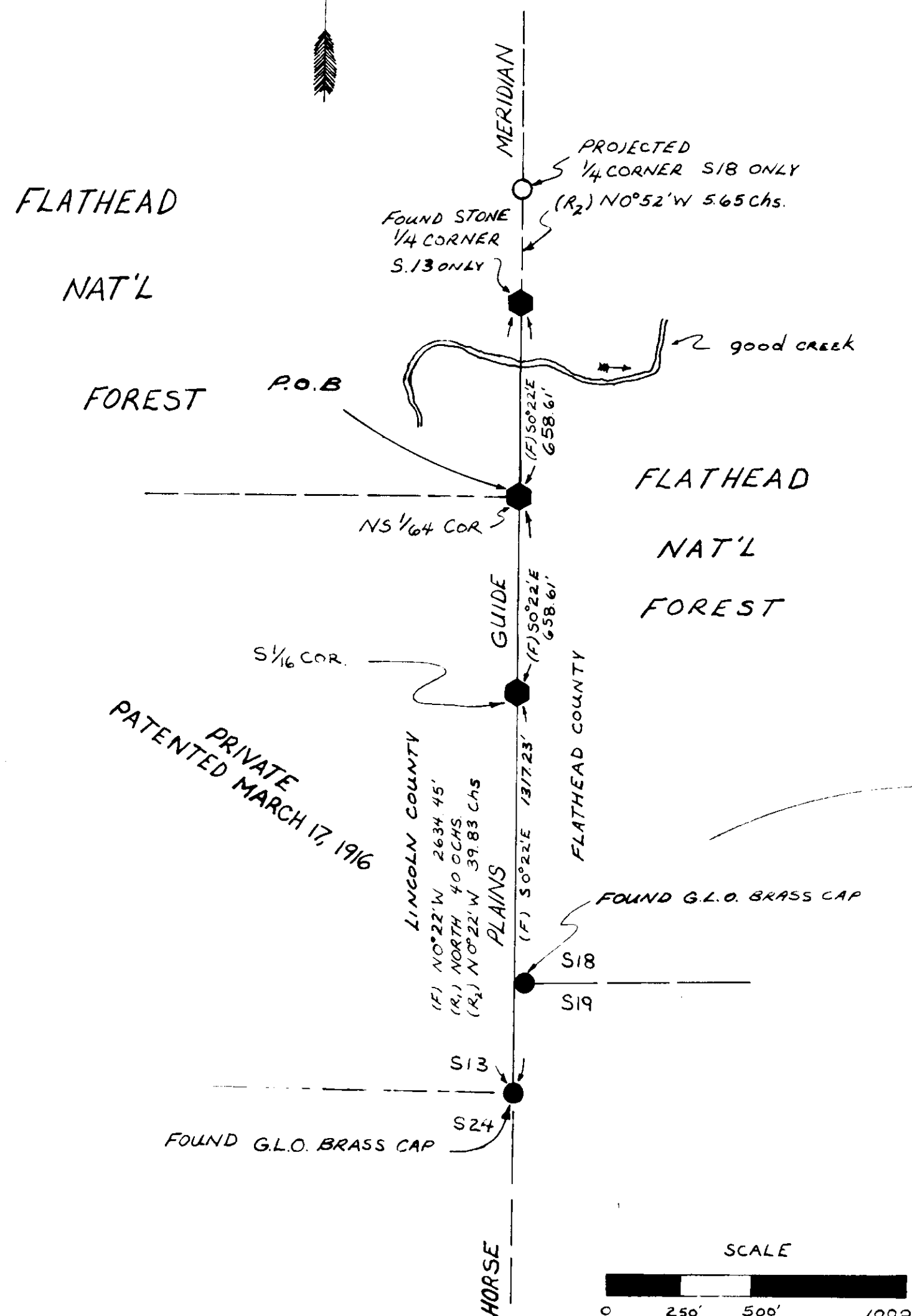

LEGAL DESCRIPTION DEPICTING THE BOUNDARY BETWEEN FLATHEAD NAT'L FOREST AND OTHER LANDS IN SECTION 13, TOWNSHIP 31 NORTH RANGE 26 WEST, PRINCIPAL MERIDIAN, LINCOLN COUNTY, MONTANA, DESCRIBED AS FOLLOWS:

COMMENCING AT THE EAST 1/4 CORNER OF SECTION 13, T.31N., R.26W., THENCE $50^{\circ}22'E$, A DISTANCE OF 658.61 FEET TO THE N-S 1/64 CORNER ON THE EAST LINE OF SECTION 13, WHICH IS THE TRUE POINT OF BEGINNING; THENCE $50^{\circ}22'E$, A DISTANCE OF 658.61 FEET TO THE S 1/16 CORNER ON THE EAST LINE OF SECTION 13; THENCE $50^{\circ}22'E$, A DISTANCE OF 1317.23 FEET TO THE EAST SECTION CORNER COMMON TO SECTION 13 AND 24, ALL ACCORDING TO THIS CERTIFICATE OF SURVEY.

PURPOSE OF SURVEY

THIS SURVEY WAS PERFORMED TO ESTABLISH PHYSICAL BOUNDARY LINES BETWEEN FEDERALLY OWNED LAND AND PATENTED LAND PREVIOUSLY CREATED IN ACCORDANCE WITH FEDERAL STATUTE. THIS SURVEY WAS DONE PURSUANT TO SECTIONS 76-3-404 MCA AND NO DIVISION OF LAND IS HERE BY CREATED.

NOTES:

THIS CERTIFICATE OF SURVEY REPRESENTS A RETRACEMENT AND DEPENDENT RESURVEY OF THE U.S. GENERAL LAND OFFICE SURVEY OF THE HORSE PLAINS GUIDE MERIDIAN, REFER TO THE OFFICAL G.L.O. NOTES AND PLATS BY ABRAM L. JAQUETH AND JAMES S. KEERL, 1893 AND THE NOTES AND PLATS BY RANNEY Y. LYMAN, 1932.

POSITIONS FOR CORNERS SET BY THIS SURVEY WERE DETERMINED BY A CLOSED TRAVERSE USING A KERN DKM-2AE THEODOLITE AND H.P. 3800 EDM., DURING OCTOBER, 1982 BY J. FAUST AND J. CARTER.

BASIS OF BEARING IS THE G.L.O. RECORD BEARING ON THE HORSE PLAINS GUIDE MERIDIAN BETWEEN THE 1/4 CORNER OF SECTION 13 AND THE SECTION CORNER COMMON TO SECTIONS 13 AND 24, T.31N., R. 26W.
