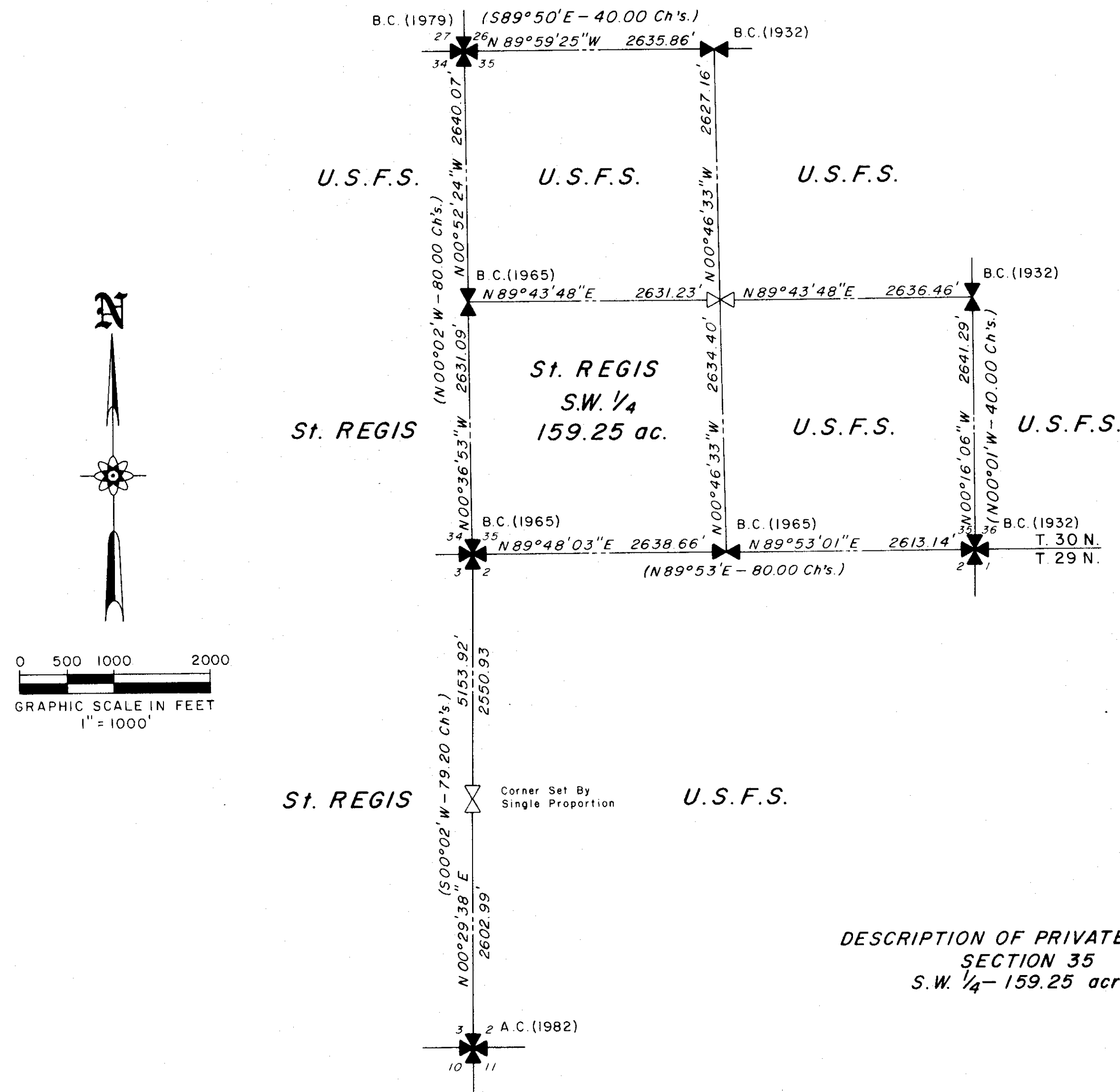


CERTIFICATE OF SURVEY No. _____

NOTES:

THIS SURVEY WAS DONE TO DELINEATE THE BOUNDARY BETWEEN THE PRIVATE LAND AND THE RESERVED PUBLIC DOMAIN IN SECTION 35, TOWNSHIP 30 NORTH, RANGE 26 WEST, AND SECTION 2, TOWNSHIP 29 NORTH, RANGE 26 WEST. THE PLAT REPRESENTS A DEPENDENT RESURVEY DESIGNED TO RECOVER OR RESTORE ALL ORIGINAL PUBLIC LAND SURVEY CORNERS TO THEIR TRUE ORIGINAL LOCATIONS ACCORDING TO THE BEST AVAILABLE EVIDENCE AND A PARTIAL SUBDIVISION OF SECTION 35 AND A RETRACEMENT OF THE WEST LINE OF SECTION 2. REFERENCE SHOULD BE MADE TO THE ORIGINAL SURVEY NOTES AND PLATS OF THESE SECTIONS. THE ORIGINAL SURVEY WAS DONE BY JAMES S. KEERL AND ABRAM L. JAQUETH IN JUNE AND JULY, 1893. IN 1932, 1965, 1979, AND 1982, THE B.L.M. REMONUMENTED STONE CORNERS WITHIN THESE SECTIONS.



THIS SURVEY WAS PERFORMED AT THE REQUEST OF THE U.S.D.A. FOREST SERVICE. IT WAS COMPLETED IN JUNE, 1983. THE SURVEY WAS ACCOMPLISHED BY CONVENTIONAL GROUND METHODS UTILIZING THEODOLITE-E.D.M. TRAVELERS. BEARINGS SHOWN ARE BASED ON SOLAR OBSERVATIONS MADE IN SECTIONS 35 AND 2. COPIES OF THE FIELD NOTES AND COMPUTATIONS ARE FILED WITH THE U.S.D.A. FOREST SERVICE, KOOTENAI NATIONAL FOREST, LIBBY, MONTANA.
